1. Balance of Trade

Balance of Trade showed a deficit of TZS 119,868.9 million in June 2024, increased by 19.6 percent compared to the corresponding month of 2023 and decreased by 4.5 percent compared to the previous month. Trade ratio for June 2024 is 3.5, decreased from 3.7 percent in June 2023 and from 3.8 percent for previous month. (Table 1).

## 2. Exports Statistics

June2024, recorded a total exports value of TZS 4,356.2 million, increased by 13.5 percent compared to June 2023 and decreased by 12.7 percent compared to previous month (May 2024). Food and live animals contributed 53.5 percent (TZS 2,331.3 million) of the total exports as seen in table 2.

## 3. Exports by Top Five Partner in June 2024

The top five trading partners for exported goods in the June 2024 accounted 68.8 percent of the total value of exported goods. Major export destination was Indonesia that accounted 24.2 percent (TZS 1,056.2 million) of the total export (Figure 1).

## 4. Imports Statistics

Month of June 2024 recorded a total import value of TZS 124,225.0 which increased by 19.3 percent compared to June 2023 and decreased by 4.8 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 39.2 percent (TZS 48,690.6 million) of the total import value followed Machinery and transport equipment section (17.3 percent). The performances of other sections are as shown in table 3.

## 5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for June 2023 was TZS $35,341.7$ million, which decreased by 1.1 percent compared to corresponding month and by 11.5 percent compared to previous month. Imports value of capital goods was TZS 33,031.1 million, which increased by 47.1 percent compared with the corresponding month and by 46.1 percent compared with the previous month. Imported value of intermediary goods was TZS 55,852.2 million, which increased by 21.6 percent compared to the corresponding month of 2023 and decreased by 17.9 percent compared to previous month.
