#### 1. Balance of Trade

Balance of Trade showed a deficit of TZS 135,367.2 million in October 2024, increased by 10.8 percent compared to the corresponding month of 2023 and by 23.8 percent compared to the previous month. The trade ratio for October 2024 increased to 17.3 from 6.9 percent in September and decreased from 10.9 percent in the corresponding month of 2023. (Table 1).

### 2. Exports Statistics

October 2024, recorded a total export value of TZS 28,226.5 million, increased by 88.2 percent compared to October 2023, and increased more than two hundred percent compared to the previous month (September 2024). Crude materials, inedible, except fuels contributed 53.9 percent (TZS 15,227.7 million) of the total exports as seen in Table 2.



# 3. Exports by Top Five Partners in October 2024

The top five trading partners for exported goods in October 2024 accounted for 95.7 percent of the total value. The major export destination was India which accounted for 55.2 percent (TZS 15,576.3 million) of the total export (Figure 1).

### 4. Imports Statistics

The month of October 2024 recorded a total import value of TZS 163,593.7 which increased by 19.2 percent compared to October 2023 and by 39.3 percent compared to the previous month. Mineral fuels, lubricants, and related materials contribute 37.9 percent (TZS 62,055.1 million) of the total import value followed by Machinery and transport equipment section (27.0 percent). The performances of other sections are as shown in Table 3.

#### 5. Import by Broad Economic Categories (BEC)

The imported value of consumer goods for October 2024 was TZS 41,032.8 million, which increased by 14.9 percent compared to the corresponding month of 2023 and by 67.9 percent compared to the previous month. Imports value of capital goods was TZS 50,793.0 million, which increased more than one hundred percent compared with the corresponding month 2023 and by 97.0 percent compared with the previous month. The imported value of intermediary goods was TZS 71,767.9 million, which decreased by 10.3 percent compared to the corresponding month of 2023 and by 6.8 percent compared to the previous month. 
