Overview of Zanzibar Economy

Gross domestic Product (GDP) in Q2/2024 went up by **7.2** percent. Total GDP in real terms marked to **894,079 TZS Million**. The performance in the period reflects the increasing of Fishing, Mining and Quarrying, Professional Scientific and Development, Construction, Accommodation and Food Services, Crops, Manufacturing, Wholesale and Retail Trade, Electricity, Administrative and Support, Human Health.

Figure 1 displays the growth rates from quarter ended June 2015 to June 2024 as measured by the percentage change in real GDP on the same quarter of the previous year (y-o-y) at constant 2015 prices. It has revealed that quarterly y-o-y growth rates were positive in all trends except two quarters which declined (third quarter of 2013 and second quarter of 2020). The declined of the second quarter for 2020 we highly attributed by crisis caused by COVID 19 pandemic that contributed to the global economic shocks during that period.

Figure 1: The Quarterly Real GDP Growth at Constant 2015 Prices from 2015-2024

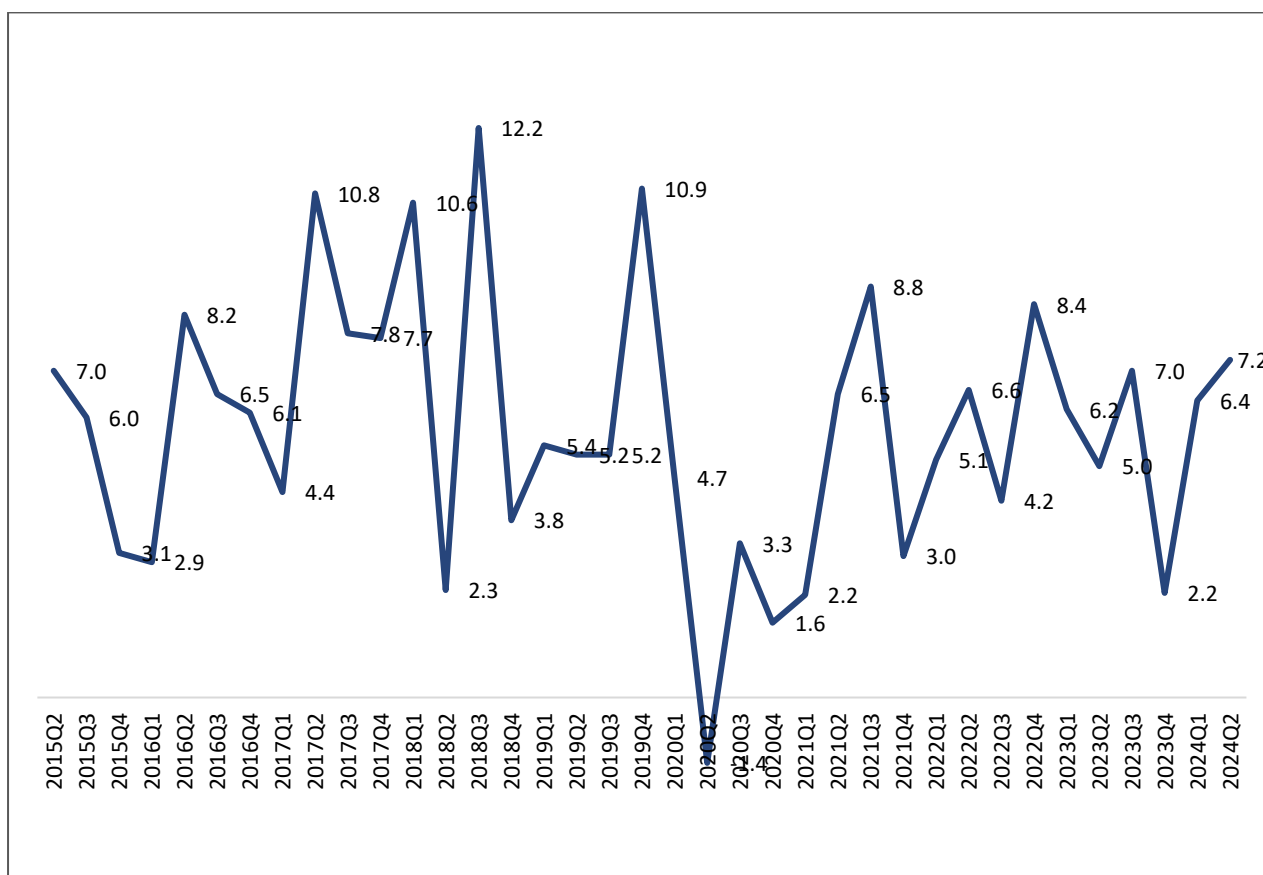
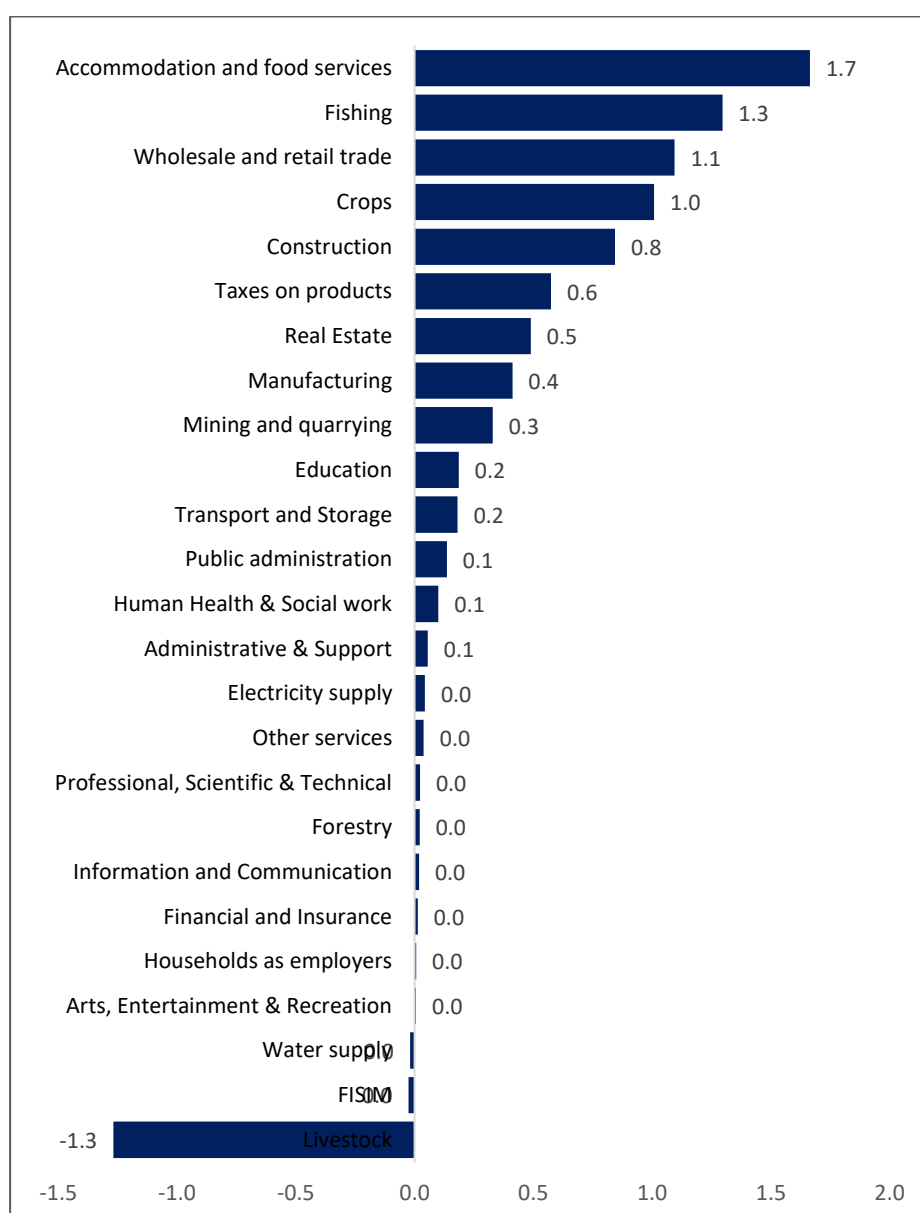


Figure 2 shows that the percentage – point contribution of each economic activity to the overall growth of 7.2 percent in the quarter ended June 2024. The positive contributors to the growth rate were Accommodation and Food services (1.7 percentage point), Fishing (1.3 percentage point), Wholesale and Retail Trade (1.1 percentage point), Crops (1.0 percentage point), Construction (0.8 percentage point), Real Estate (0.5 percentage point), Manufacturing (0.4 percentage point), Mining and Quarrying (0.3 percentage point), Education and Storage activities both marked (0.2 percentage points), Public Administration, Human Health and Support activities all of them marked (0.1 percentage point).

In this quarter, Livestock economic activity contributed negatively (1.3 percentage point).

GDP levels (Nominal or Current Prices)

Total GDP for the June 2024 quarter in nominal terms registered **1,454,012 TZS million**, grew by **0.2** percent compared with same quarter ended June 2023. The growth is attributed by growth for Water supply, Professional Scientific and Technical, Arts, Entertainment & Recreation, Public Administration, Fishing, Accommodation and Food Services, Administrative & Support, Transport and Storage activities, Crops, Information and Communication, Financial and Insurance, Real Estate, Human Health.

Figure 3: Percentage Share of Economic Activities to Total GDP

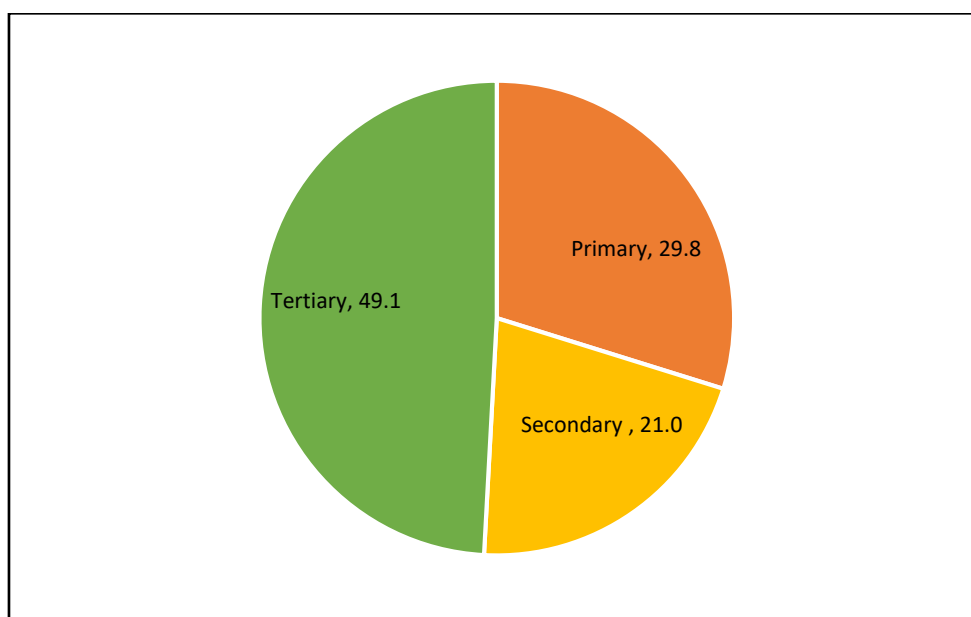


Figure 3 shows that the composition of GDP at current prices for quarter ended June 2024, categorized into the three main broad sectors of the economy, Primary Sector (Agriculture sector), Secondary Sector (Industry sector) and Tertiary Sector (Services Sector).

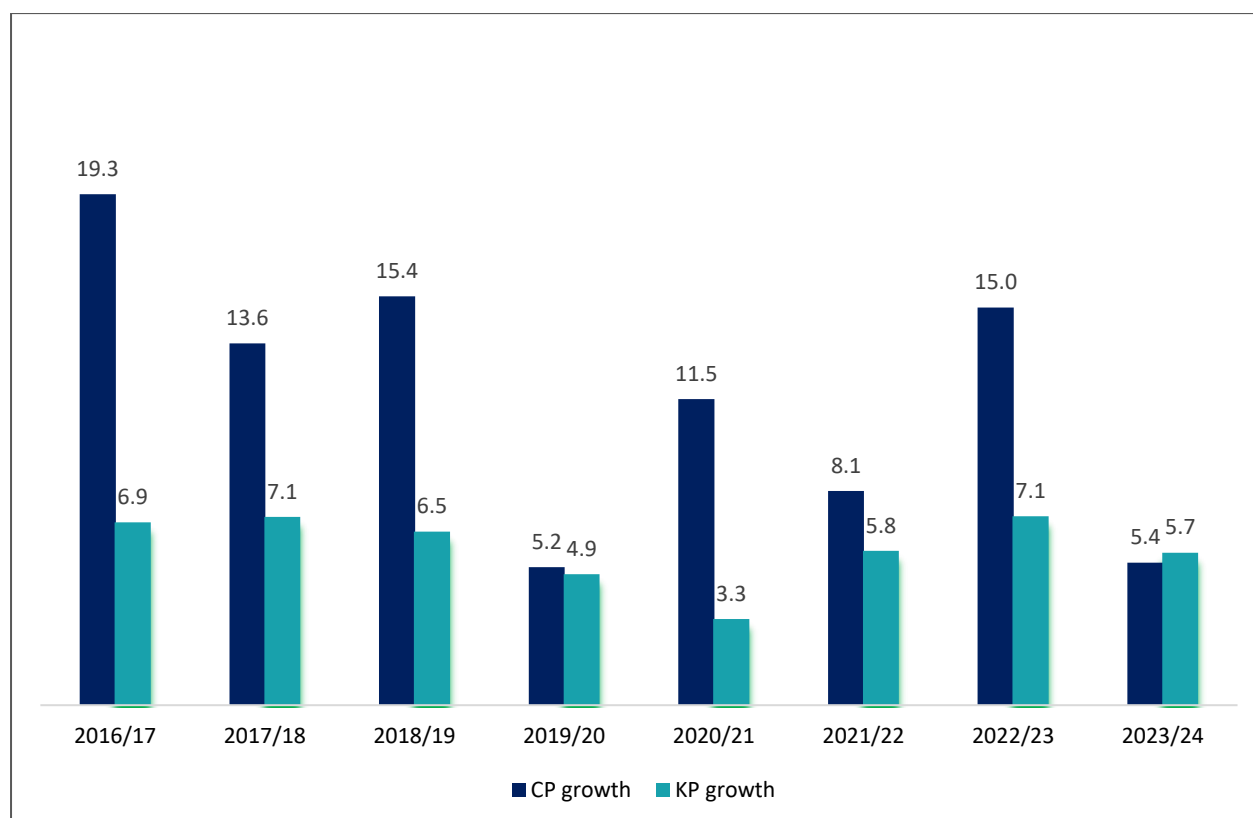
Tertiary sector remains the largest that comprising a total share of **49.1** percent of total GDP, increased by **8.6** percent point when compared to share of the same quarter of 2023 quarter. Primary sector recorded a total share of **29.8** percent that decreased by **6.6** percent and Secondary sector recorded a share of **21.0** percent that decreased by **15.6** percent Point.

Twelve Months Review (September 2023 - June 2024)

At constant 2015 prices (real terms), GDP stood at **3,830,282 TZS million** recording an increase of **5.7** percent compared to the 12 months period ended June 2024. This percentage increase was evident that favorable economic performance attributed by industries such as Fishing, Mining and Quarrying, Professional Scientific and Development, Construction, Accommodation and Food Services, Crops, Manufacturing, Wholesale and Retail Trade, Electricity, Administrative and Support, Human Health to mention a few.

Figure 4 shows the growth rates for the 12 months period and is the sum of four quarters, i.e. the quarter start from quarter ended September 2023 to quarter ended June 2024. Similarity, the trend goes back to year 2016/17. As it is shown by the figure, economic activities in the 12 months period September 2016/17 to June 2023/24 have been steadily showing favorable performances for the 12 months period ending June 2024.

Figure 4: Percentage change in Current and Constant Prices for the year ended September (2016/17 - 2023/24)



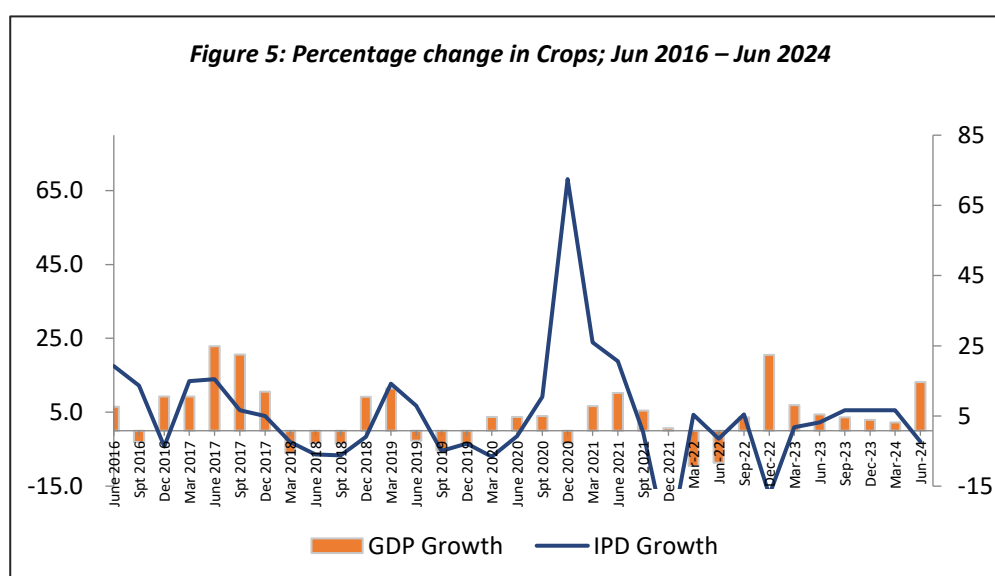

The Crops sub-sector generated a total value added in real terms of **72,402 TZS million** in the period under review. During June 2024 quarter, the activity increased by **13.1** percent and also increased by **0.8** percent when compared to June 2023 quarter and March 2024 quarter respectively. The industry contributed a positive **1.0** percentage points to overall GDP growth across the June quarter 2024.

In nominal term, the crops activities account for positive performance of **10.5** percent (y-o-y) at current prices that marked **116,318 TZS million** value added. The changes from June 2024 quarter experience a positive GDP growth **1.0** percent (q-o-q).

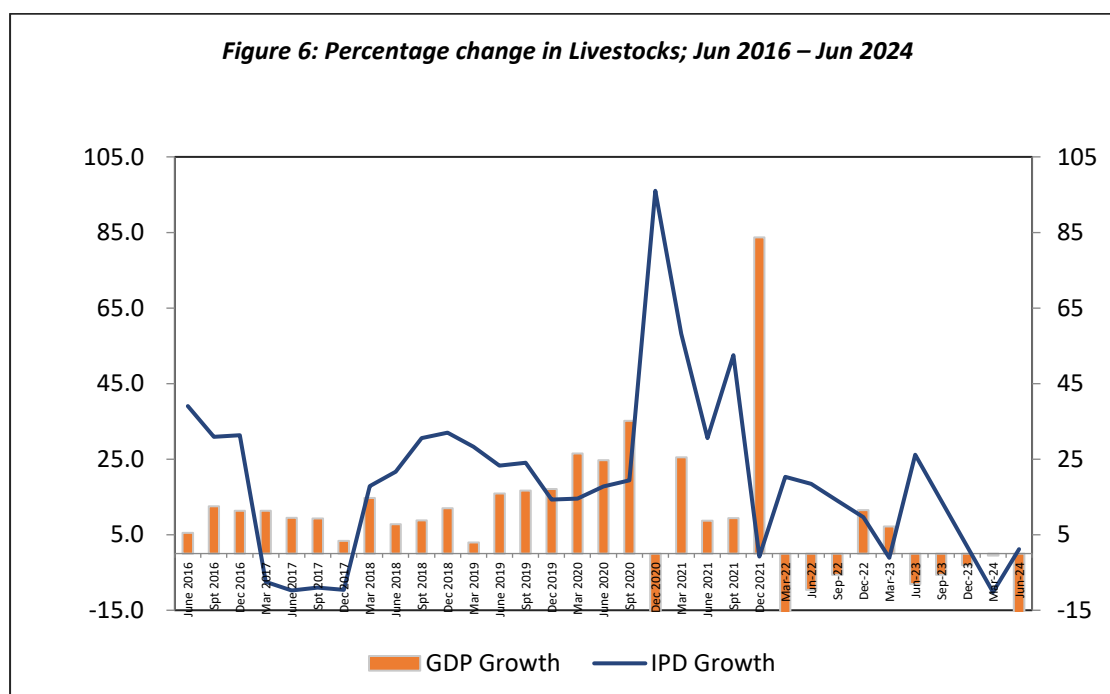

Livestock recorded a total value added of **42,203 TZS million** in constant prices for the period under review. The industry contributed negatively to the overall GDP growth rate with **20.0** percent.

In nominal term, the livestock activities account for negative performance of **19.1** percent (y-o-y) at current prices that marked **200,497 TZS million** value added. The changes from March 2024 quarter experience a positive GDP growth of **17.3** percent (q-o-q).

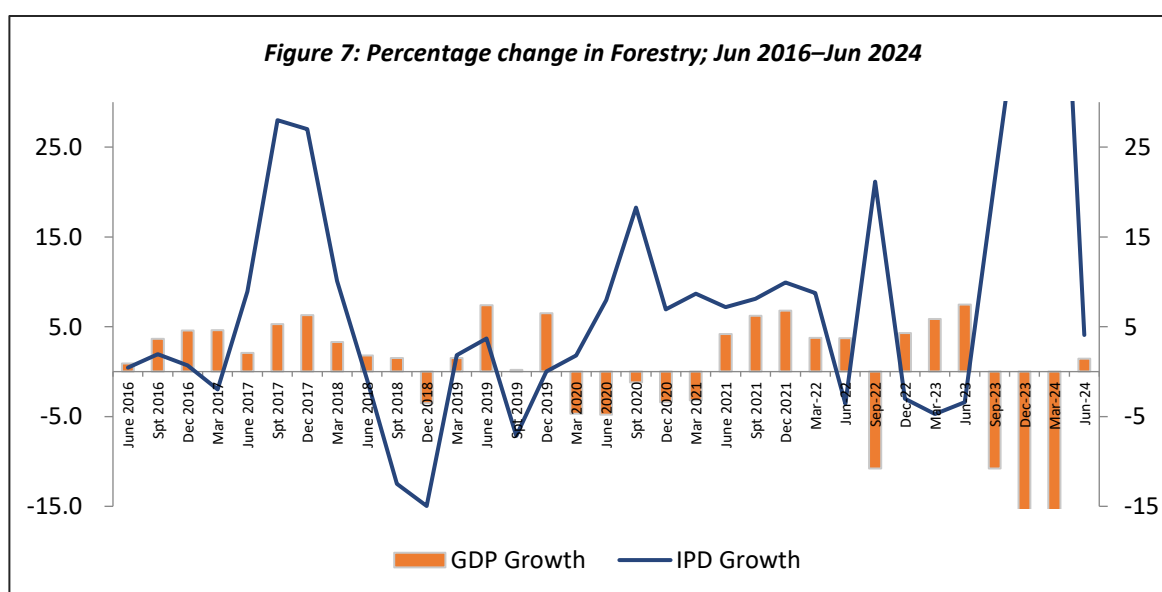

Forestry registered a total value added of **12,675 TZS million** at constant 2015 prices for the period under review. The industry contributed positively to the overall GDP growth rate with **1.4** percent. The favorable performance by the industry was in line with the increased of volume of forestry products.

The Value Added at current prices for forestry activities marked the value added of **15,675 TZS million** that result a positive growth **5.6** percent (y-o-y). These activities account for **1.1** percent as a share to total GDP.

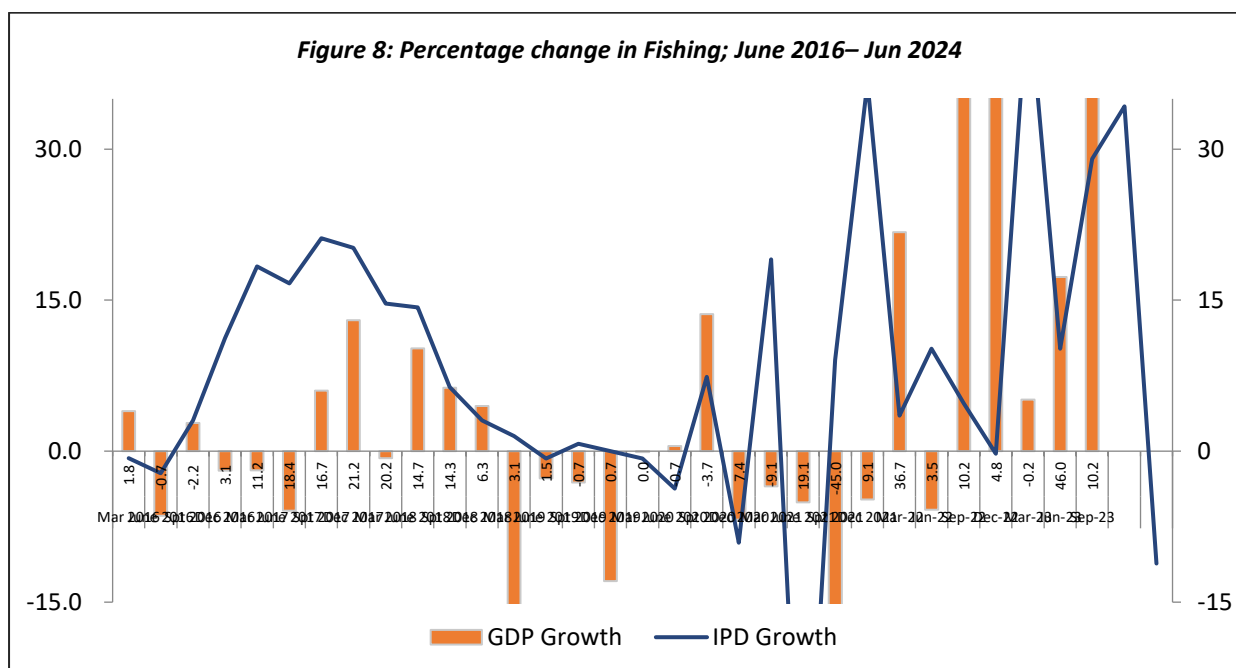

Fishing activities recorded a total value added of **47,834 TZS million** at constant 2015 prices for the period under review. This amount results the positive growth of real Value Added by **29.2** percent during the June quarter 2024. The change between March 2024 and June 2024 decreased by negative **0.6** percent.

The value added at current prices registered **60,011 TZS million** for the June quarter 2024 (y-o-y) that marked a positive **14.8** percent of growth. This value-added registered **4.1** percent share to total GDP.

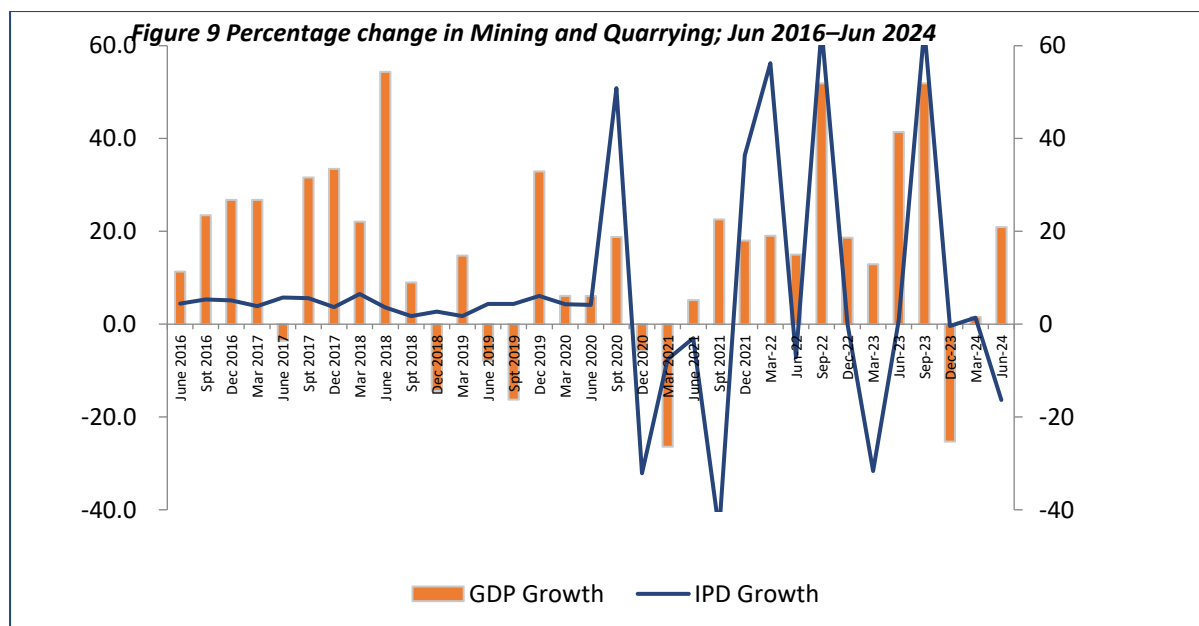

Mining and Quarrying activities registered a total value added of **15,850 TZS million** at 2015 constant prices for the period under review. The industry contributed positively to the real GDP growth rate with 20.9 percent for June 2024 quarter.

In nominal term, the Mining and Quarrying activities accounts for positive performance of **1.1** percent (y-o-y) at current prices that marked **14,925 TZS million** value added. The changes from March 2024 quarter experience a positive GDP growth of **3.7** percent (q-o-q).

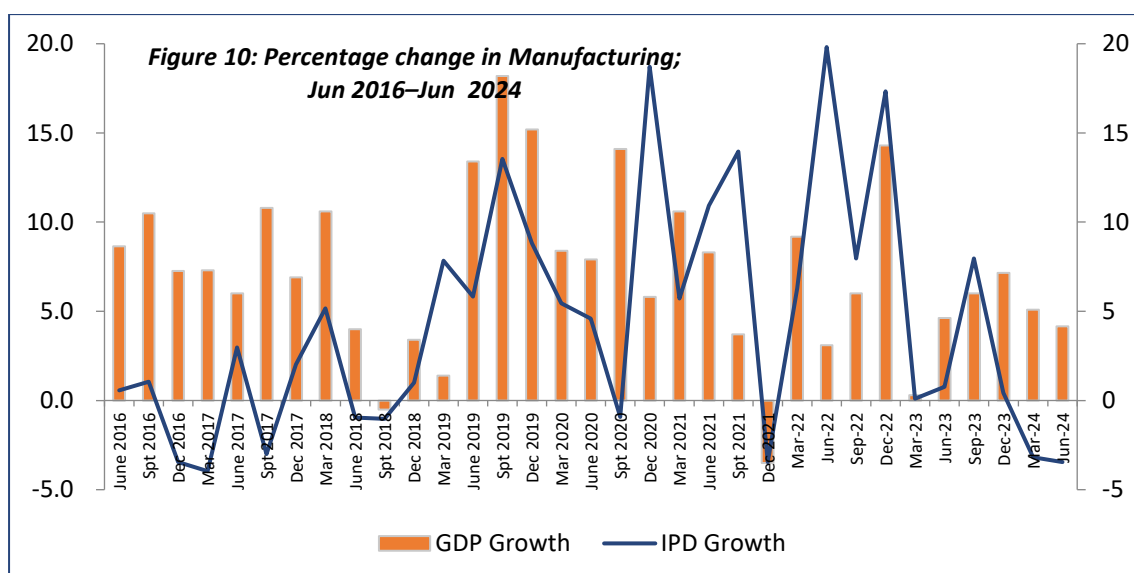

The manufacturing industry marked a total value added of **85,977 TZS million** in real term for the period under review. The industry contributed positively to the overall real GDP growth with **4.2** percent for June quarter 2024. Similarly, the industry observed a positive performance of **0.8** percent (q-o-q) for June 2024 quarter from March 2024.

Current prices registered a positive growth of **0.6** percent for June 2024 quarter (y-o-y). On other hand, the change between March quarter 2024 and June quarter 2024 experienced a positive rate of **6.2** percent.

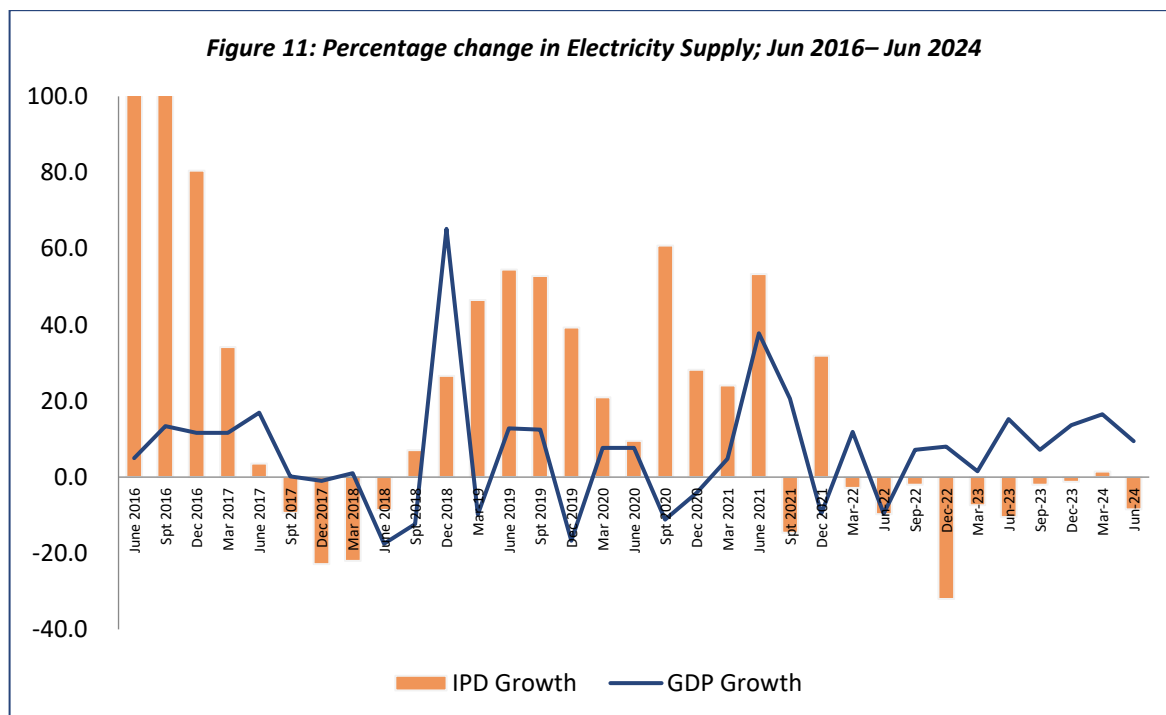

Electricity Supply value added at constant prices registered **4,238 TZS million** which produce a change of growth of positive **9.4** percent for June 2024 quarter compared to same quarter of previous year. The change from March 2024 quarter to June 2024 decreased by negative **8.8** percent.

In nominal term, the industry recorded a total value added of **15,867 TZS million** which is an increase of **0.1** percent (y-o-y). This electricity economic activity contributed **1.1** percent as a share to total GDP.

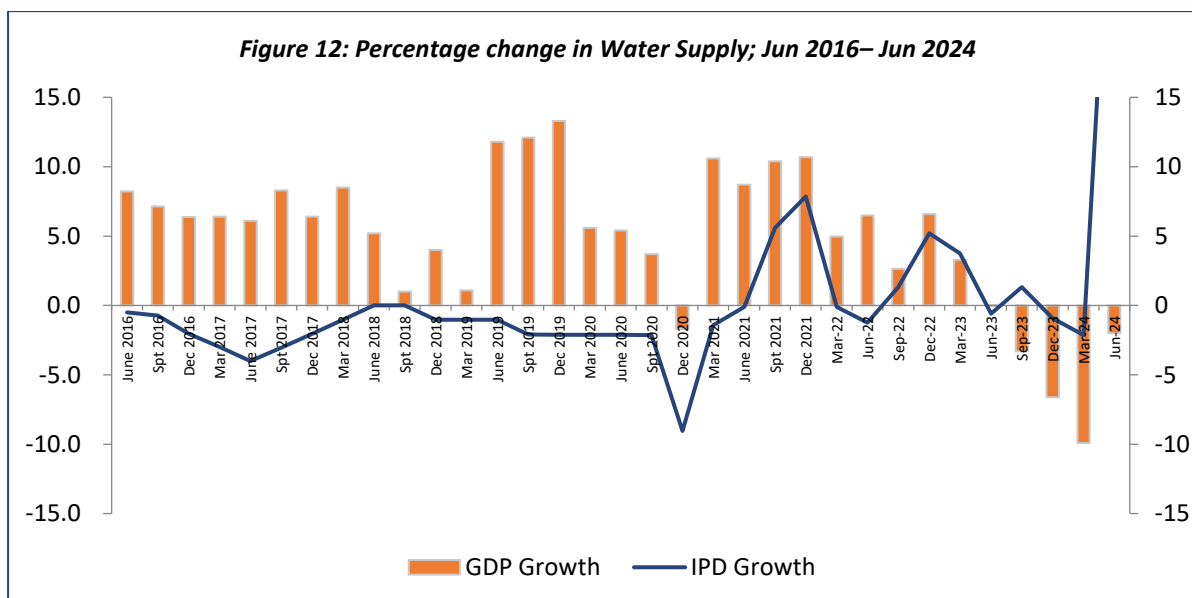

Water was among the industries that have shown a negative performance. As it stood, the industry recorded a **7,865 TZS million** value added in real terms for the period under review. The industry produces a change of negative growth of **2.0** percent for June 2024 quarter compared to same quarter of the previous year, and negative **8.6** percent compared to the March 2024 quarter.

At current prices, the industry recorded a total value added of **9,826 TZS million** which marked an increase of **33.8** percent (y-o-y) and contributed to **0.7** percent to total GDP.

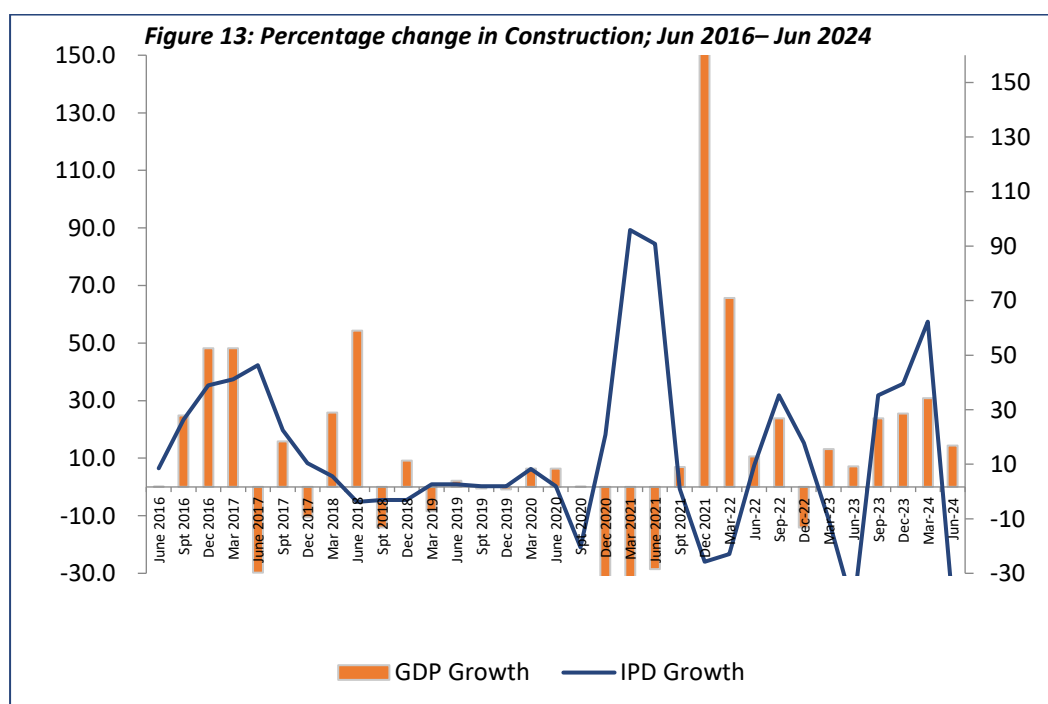

At constant 2015 prices, construction economic activity registered **55,935 TZS million** which produce a change of growth of positive **14.4** percent for June 2024 quarter compared to June 2023 quarter. Furthermore, the change from March 2024 to June 2024 have also grown by a negative growth of **23.3** percent.

In nominal term, the industry marked **109,683 TZS million** in June 2024 quarter that registered a decrease of **33.2** percent compared to June 2023 quarter.

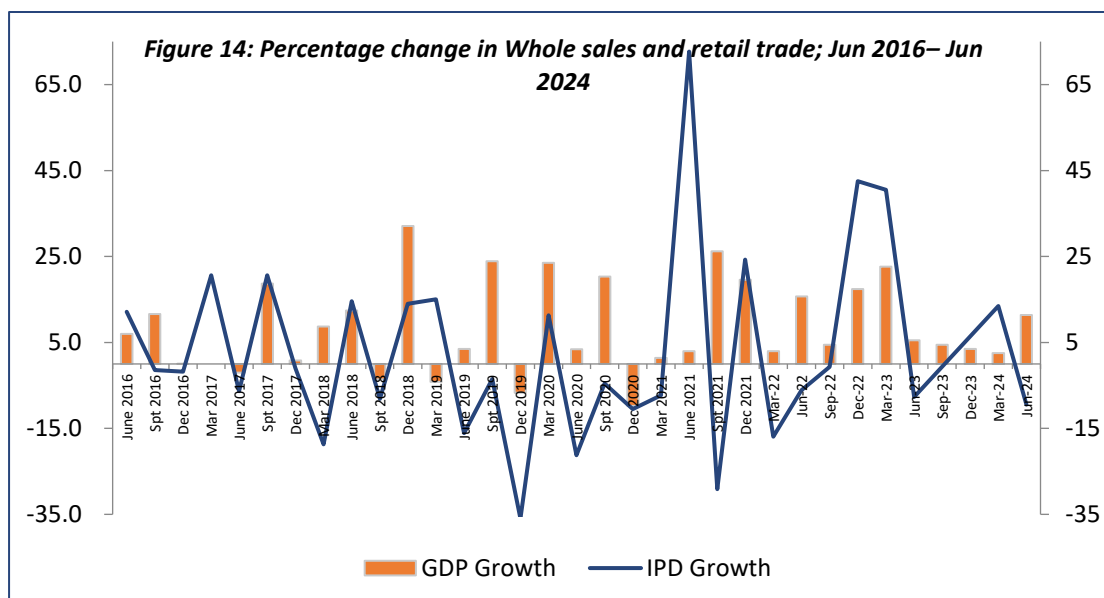

Wholesale and retail trade industry generated a total value added of **89,040 TZS million** at constant 2015 prices. In quarter ended June 2024, the industry recorded change of increase of **11.4** percent year on year (y-o-y). The economic activity marked a positive percentage point of **1.1** to overall GDP growth.

Current prices registered to **120,130 TZS million** for June 2024 quarter. At the same time the June quarter of this industry registered **8.3** percent of share to total GDP.

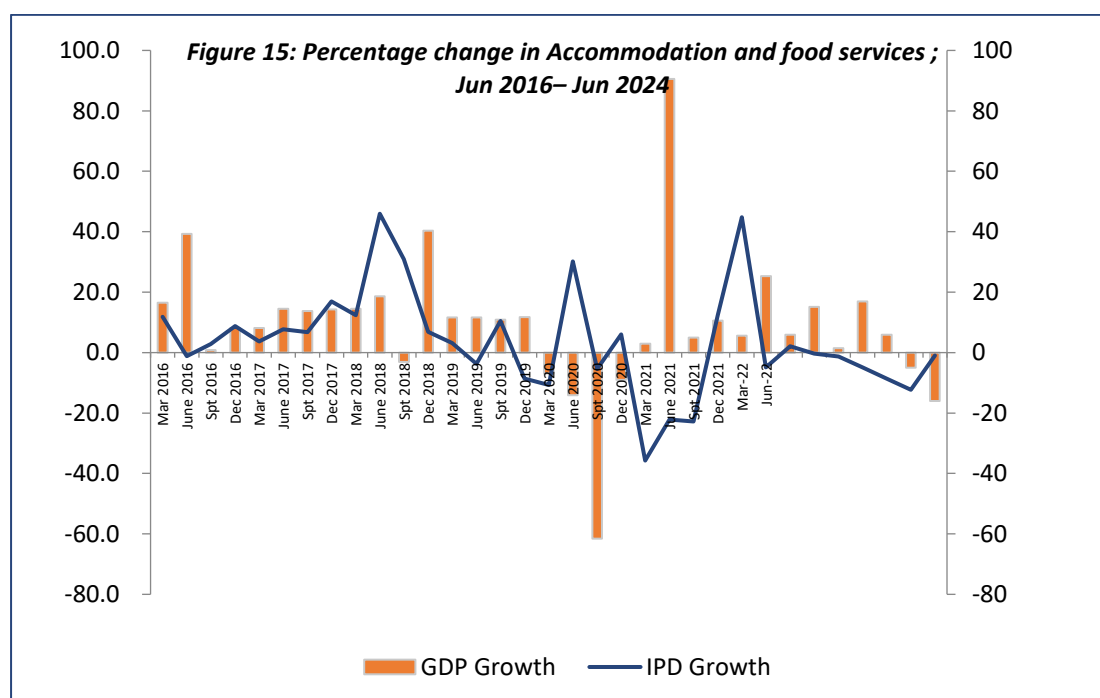

Accommodation and Food Services recorded a total value added of **114,197 TZS million** at constant 2015 prices that produced a growth of positive **13.8** percent for June 2024 quarter as compared to June 2023 quarter. The change from March 2024 to June 2024 in real term decreased by **37.7** percent.

At current prices, Accommodation and Food Services performed a positive y-o-y growth rate of 12.8 percent which registered for total value added of **121,654 TZS million**.

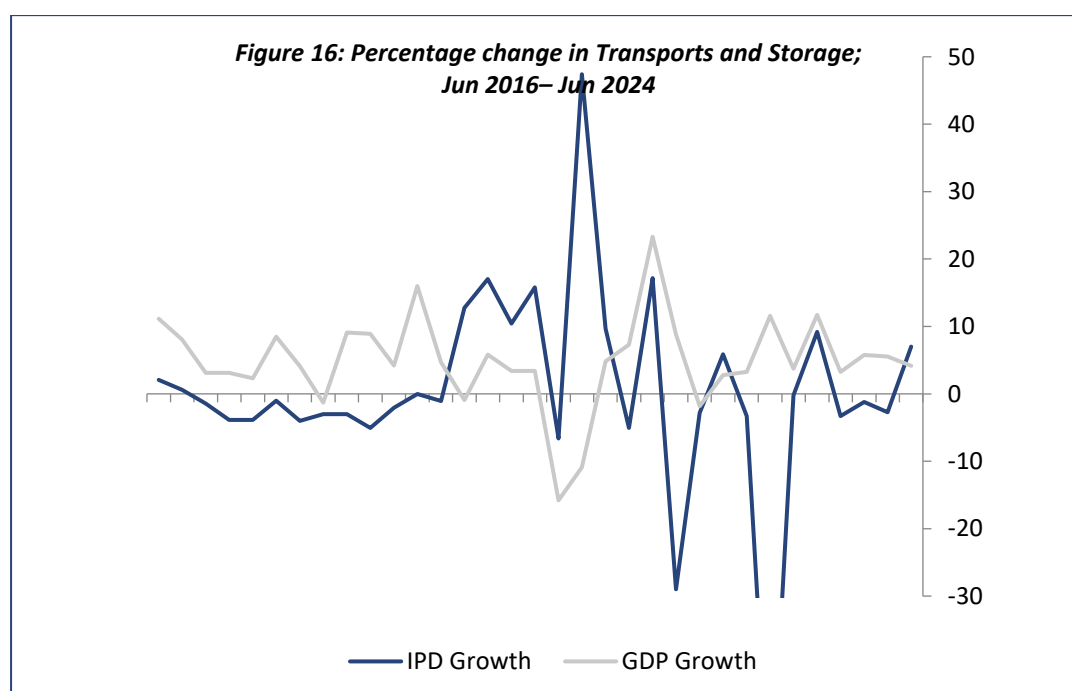

The current prices for this economic activity accumulated a total value added of **42,934 TZS million** in Nominal terms.

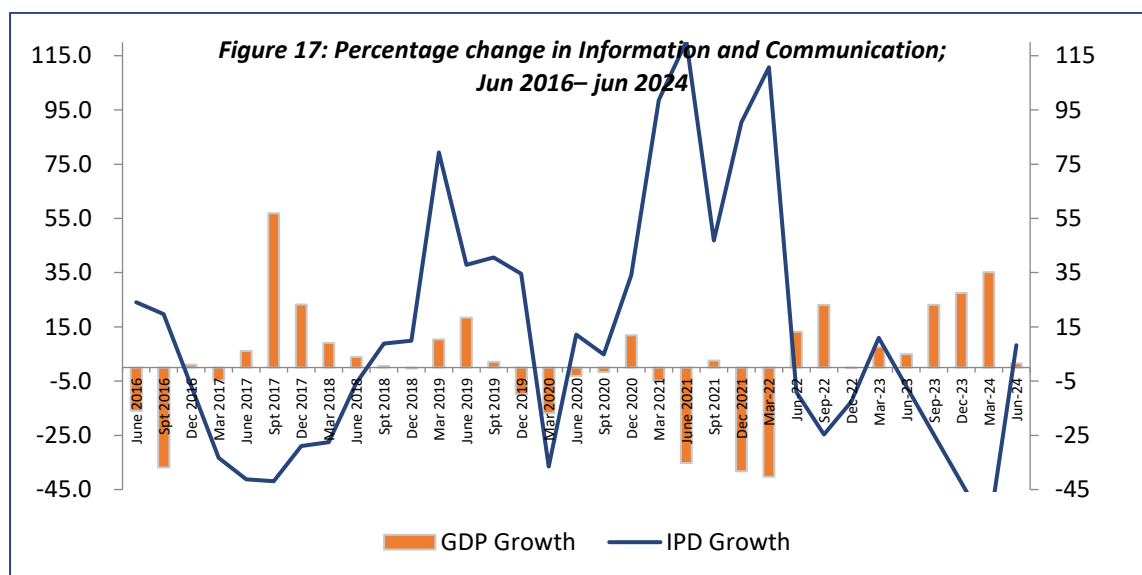

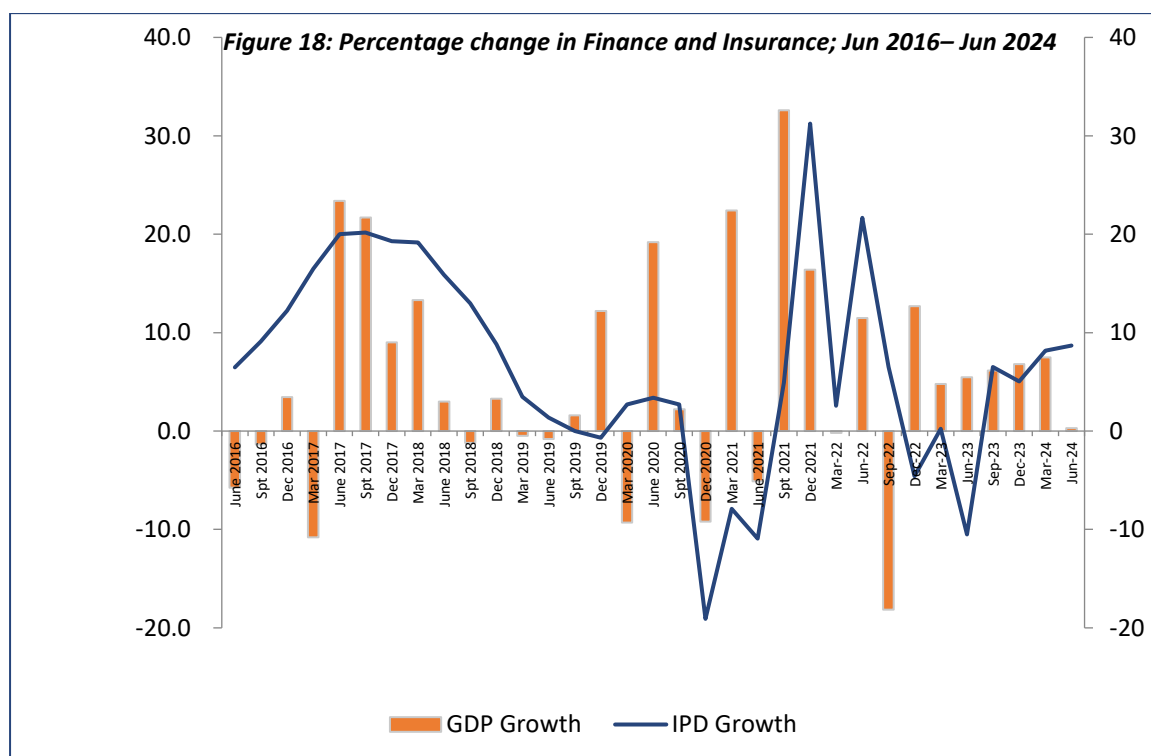

At current prices, the industry recorded a total value added of **88,148 TZS million**. The industry contributed **6.1** percent of total GDP.

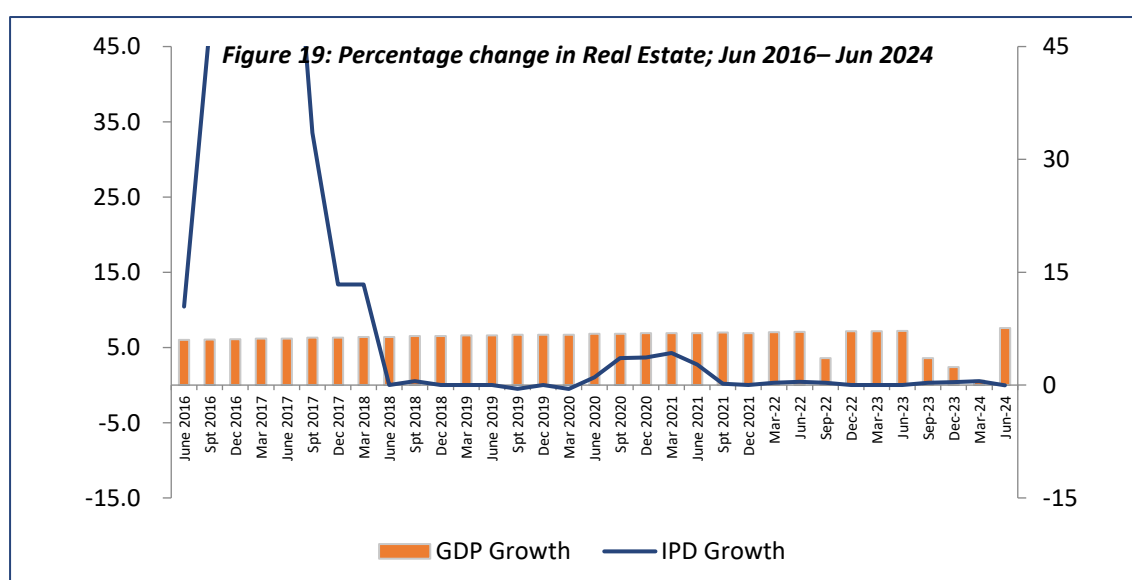

At constant 2015 prices, Real Estate value added stood at **57,882 TZS million** for June quarter of 2024. The industry's performance increased by **7.6 percent** when compared to the same period last year. The increase in value added reflects the increasing demand by the real estate activities. When compared to the March 2023 quarter, value added increased by **1.8 percent**.

In nominal terms, the value added stood at **117,592 TZS million** that reflects an increase of **7.6 percent** for June 2024 quarter as compared to the same quarter of the previous year.

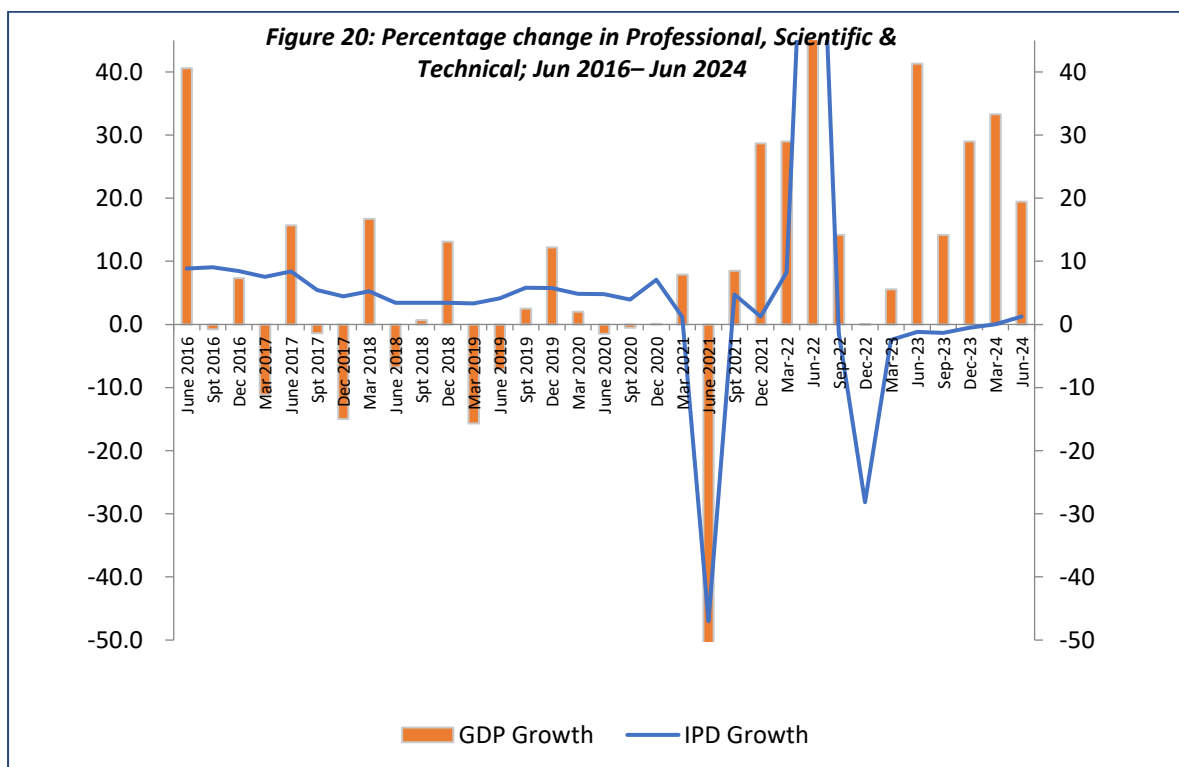

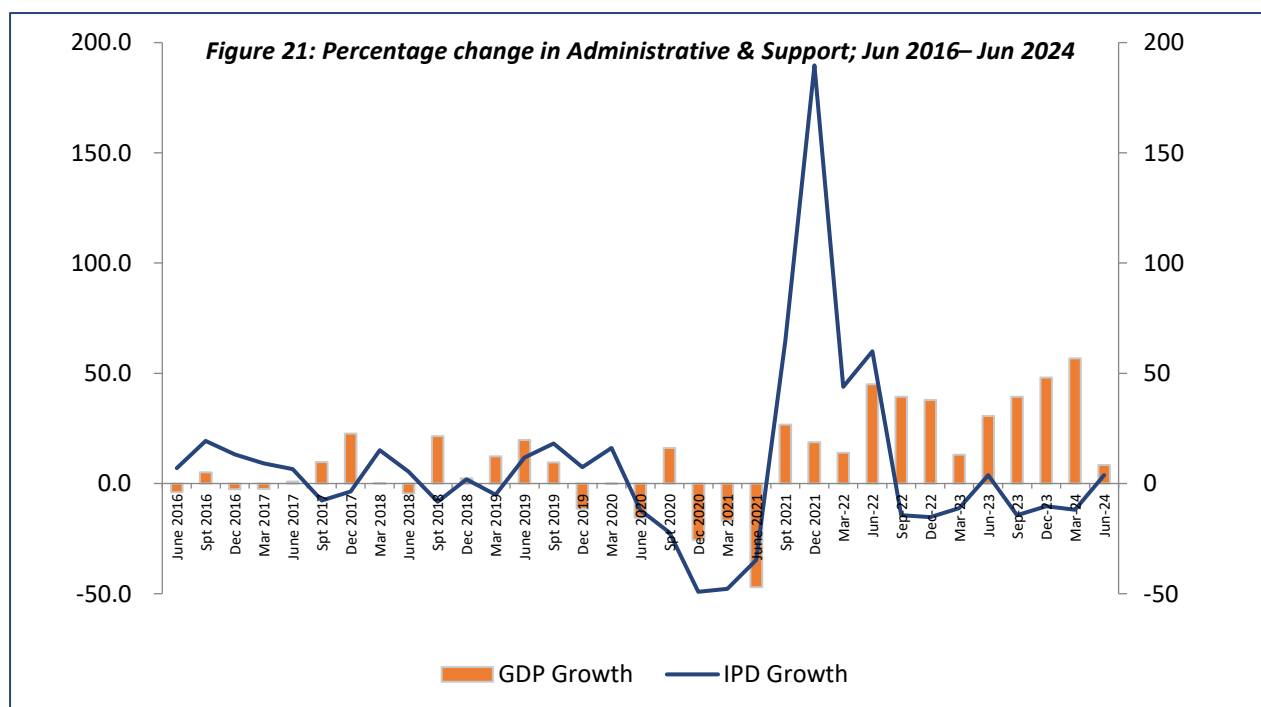

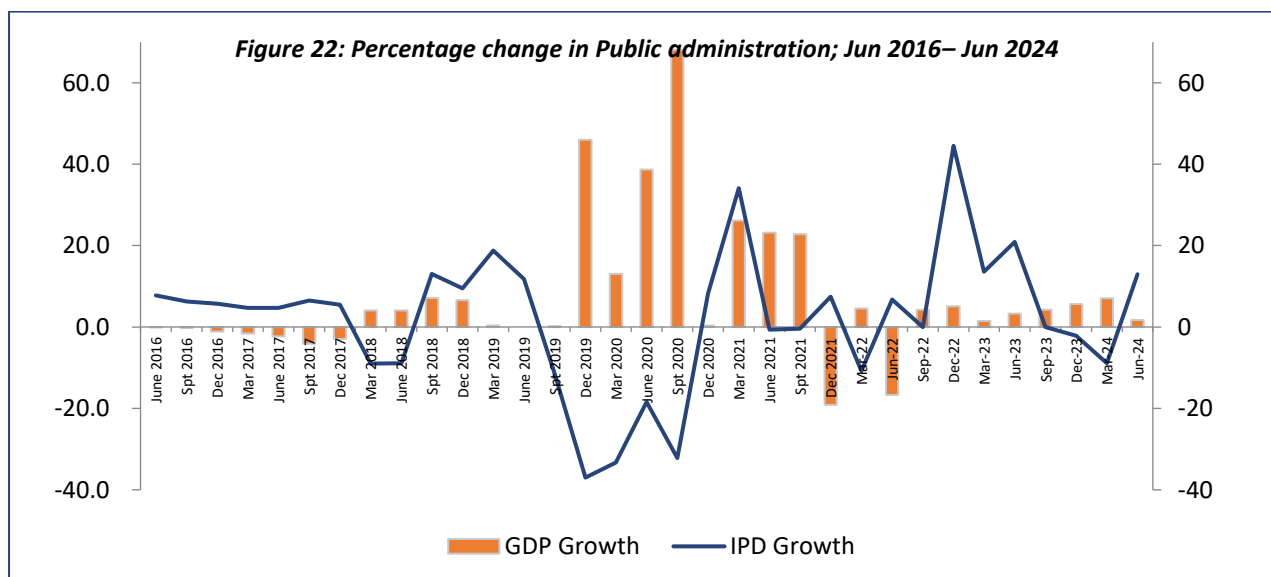

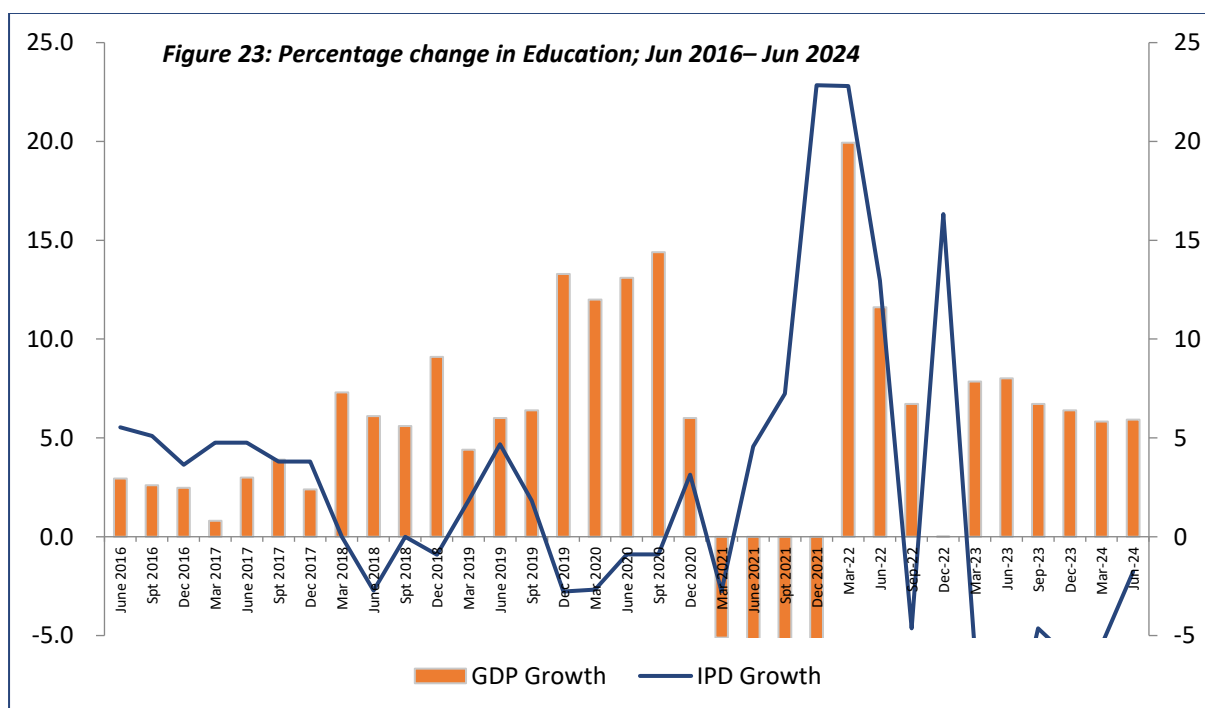

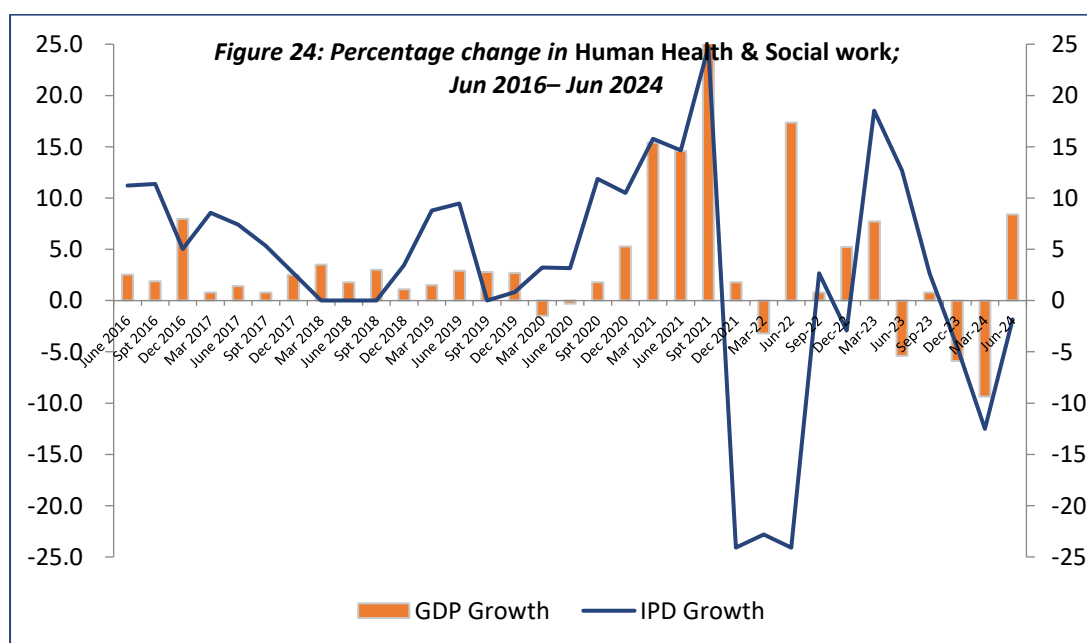

For the period under review, the Human Health & Social Work industry generated a value added in constant prices of **10,808 TZS million**.

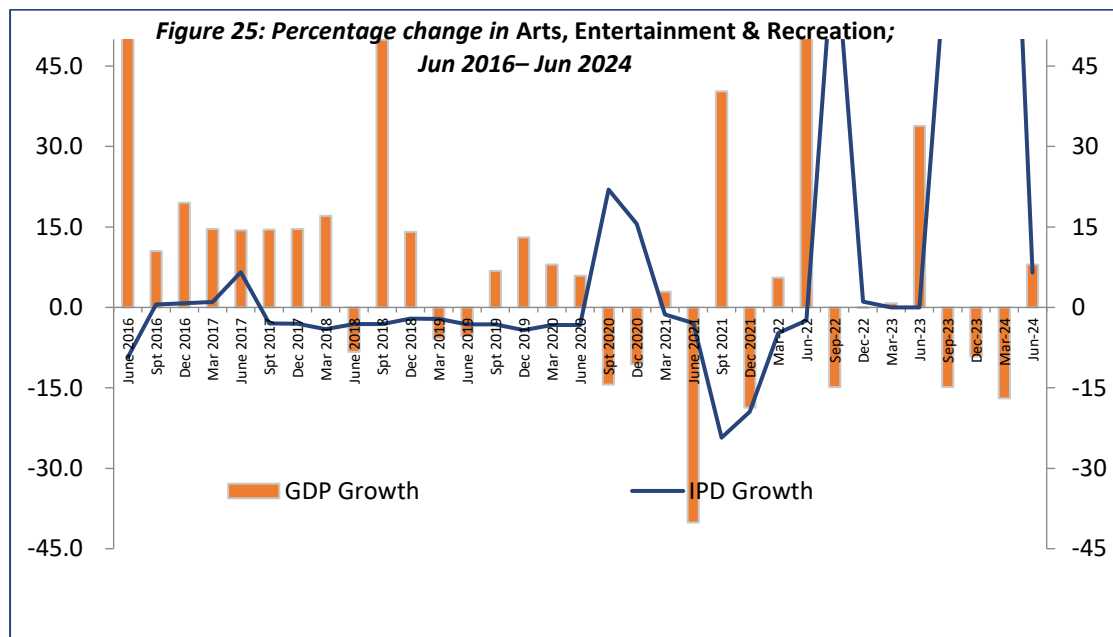

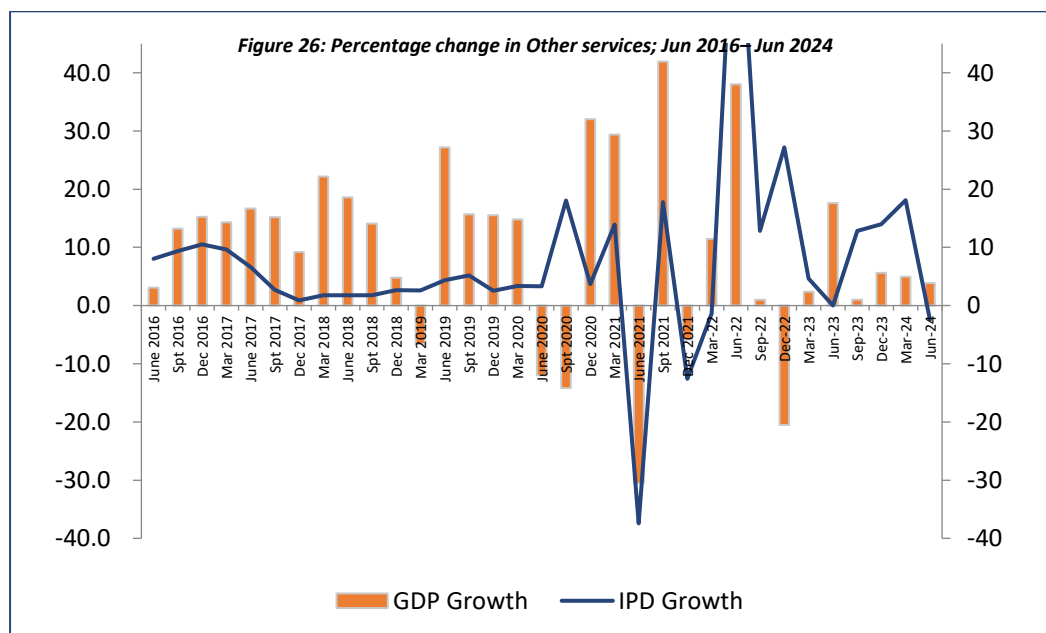

At the same time the June quarter of this industry registered **0.8** percent of share to total GDP.

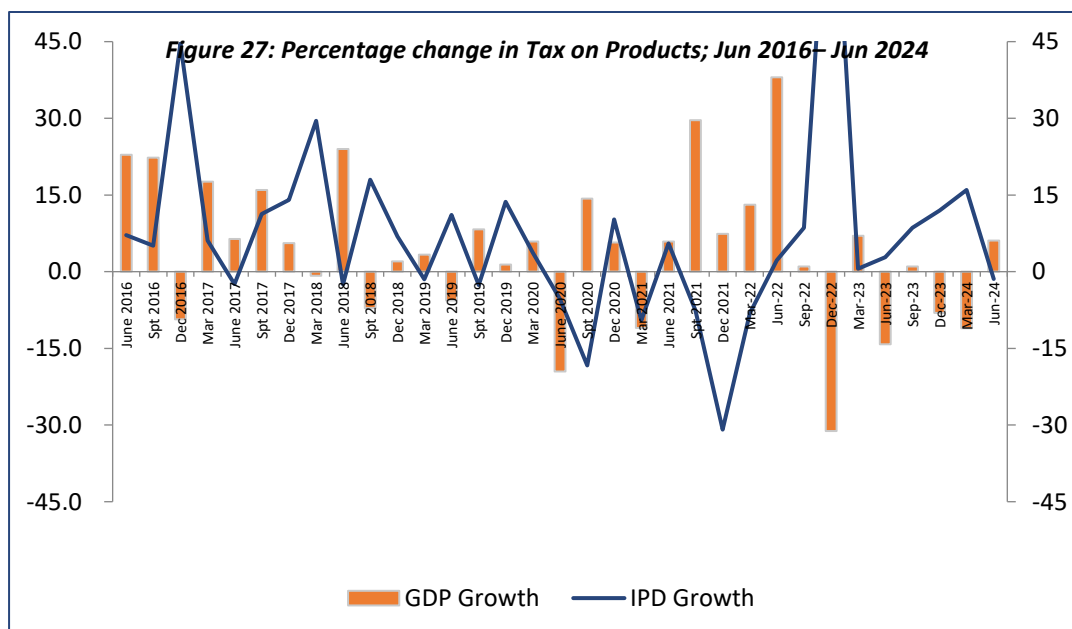

The Taxes on Products generated a total value added in real terms of **83,586 TZS million** in the period under review. The value added for quarter ended June 2024 grew by **6.1** percent compared with 2023 similar quarter.

At current prices, the value added registered **137,457 TZS million** with a positive performance of 4.6 percent from June ended quarter 2023 to June 2024 (y-o-y). When compared to March 2024 ended quarter the value added increased by **14.0** percent on q-o-q basis.



Introduction

The compilation of national accounts statistics is a dynamic process, and therefore needs to adapt to reflect a variety of measures and indicators consistent with developments and structural changes in the economy over a period. It is therefore expected that revisions and updates are made to the historical series on a quarterly or annual basis as new data sources are brought into the model and as various benchmarks and assumptions are validated and updated.

This quarterly report is the 37th published by the Office of the Chief Government Statistician of the quarterly series of GDP estimates at constant 2015 prices. This report is an ongoing publication and can also be downloaded from our website www.ocgs.go.tz.
