#### 1. External Trade Performance.




Figure 1: Trade Performance for the Q4, 2024

Total trade for the fourth quarter, 2024 reached to TZS 526,372.4 million; in which exports value worth TZS 44,683.1 million (domestic export contributes 42,264.0 million and re-export contributes 2,419.1 TZS million) and import worth TZS 481,689.4 million. The trade balance showed a deficit of TZS 437,006.3 Million (Table 1; figure 1).

The trend indicates that, total exports increased 10.5 percent compared with corresponding quarter of 2023 and more than one hundred percent compared to previous quarter. The exportation of cloves in the fourth quarter led to the decreased in the value of exports. Imports value increased by 24.4 percent compared with corresponding quarter of 2023 and increased by 16.1 compared by previous quarter (Figure 2).

# 2. Exports Statistics

# 2.1. Exports by SITC section

The value of exports includes 'Export of goods for direct home use, Re-export after outright importation, Re-export after temporary import of goods on hire purchase and re-export after customers warehousing procedure.




Figure 3: Percentage Distribution of Exports by SITC Section, Q4 – 2024

In the fourth quarter of 2024, food and live animals section contributed 38.5 percent of the total exports followed by Crude materials inedible, except fuels 35.0 percent. (Figure 3 and table 2).

# 2.2. Exports of Main Cash Crops

A total of 1,571.9 tons, valued at TZS 2,150.5 Millions of Seaweeds have exported in the fourth quarter of 2024, showing at decreasing value by 42.0 percent compared with the corresponding quarter of 2023 and increased by 77.0 percent compared with the previous quarter (Figure 5 and table 3).




Figure 4: Exports of Seaweeds by Countries of Destination, Q4 - 2024

Exports of Seaweeds shows that decreased by 4.8 percent of the total export value, which have exported on about four countries as shown in figure 4.




Figure 5: Trend of Exported Cloves and Seaweeds, Q4 - 2023, Q3 & Q4 - 2024

A total of 74.1 tons, valued at TZS 936.8 Millions of Cloves were exported in the fourth quarter of 2024, the value has decreased by 97.1 percent compared with corresponding quarter and increased by 79.8 percent compared with previous quarter. (figure 5 and table 3).

### 2.3. Exports by Top Ten Countries of Destination




Figure 6: Distribution of Exports Value by Top Five Countries of Destination, Q4, 2024

The top ten trading partners for exported goods in the fourth quarter of 2024 were India, Hong Kong, Comoros, United Arab Emirates, Bangladesh, Kenya, China, Uganda, United States of America, and Spain with a total value of TZS 44,683.1 million that accounted 95.8 percent of the total value of exported goods (Figure 6).

#### 3. Imports Statistics

The value of imports includes 'Importation for direct home use (duty and tax fully paid)', 'Importation by, or solely for use in Zanzibar' and other importation procedure (Excludes all transfer goods).

# 3.1. Imports by SITC Section




Figure 7: Percent Distribution of Import Value by Broad Economic Categories, Q4, 2024.

In the fourth quarter of 2024, Mineral fuels, lubricants and related materials contributed 40.2 percent and Machine and transport equipment which contributed about 22.9 percent of the total import, the performance of other categories are as shown in figure 7 and table 6.

#### 3.2. Import by Categories

In the fourth quarter, import of intermediate goods reached to TZS 222,706.0 million of total import (46.2 percent) while capital goods reached to TZS 144,084.7 million (29.9 percent) and import of consumer goods reached to 114,898.6 million (23.9 percent) at the fourth quarter of 2024 are as shown in figure (Figure 8 and table 7).

The Imported value of consumer goods for the fourth quarter increased by 35.5 percent compared with corresponding quarter and by 27.8 percent compared to the previous quarter. Imports of intermediary goods decreased by 9.7 percent compared with corresponding quarter and by 2.9 percent compared to the previous quarter. Import of capital goods increased by


more than one hundred percent and increased by 51.0 percent for the corresponding quarter and previous quarter respectively. (Figure 9 and Table 7).

#### 3.3. Imports by Country of Origin


The top ten trading partners for imported goods in the fourth quarter of 2024 contributed a value of TZS 481,689.3 million, equivalents to 87.0 percent of the total import. United Arab Emirates was the top by accounting 43.4 percent of the value of the imported goods. (Figure 11 and table 9).



4. Transferred goods

A total of goods worth TZS 41,944.6 Million transferred to Tanzania Mainland from Zanzibar in the fourth quarter of 2024 (Figure 13). Percentage transferred of goods shows that 64.8 percent (TZS 27,197.3 Million) of the total value of transferred goods were Animal and vegetable oils, fats & waxes, Food and live animals while 20.6 percent (TZS 8,649.5 million) were Machinery and transport equipment were 5.5 percent (TZS 2,307.4). Miscellaneous manufactured articles were 4.7 percent (TZS 1,969.0). Manufactured goods classified chiefly by material were 2.0 percent (TZS 842.1 Million). Crude materials, inedible, except fuels were 1.4 percent (TZS 842.1). Chemicals & related products, n.e.s were 0.7 percent (TZS 292.7 Million). Mineral fuels, lubricants and related materials were 0.2 (TZS 65.8). Beverages and tobacco were 0.1 percent (TZS 28.4). The performance of other transferred goods are as shown in figure 12 and Table 10.

The trend shows that value of transferred goods to Tanzania Mainland from Zanzibar decreased by 47.6 percent compared with the corresponding quarter and increased by 44.3 percent previous quarter of 2024. (Figure 13 and Table 10).
