Overview

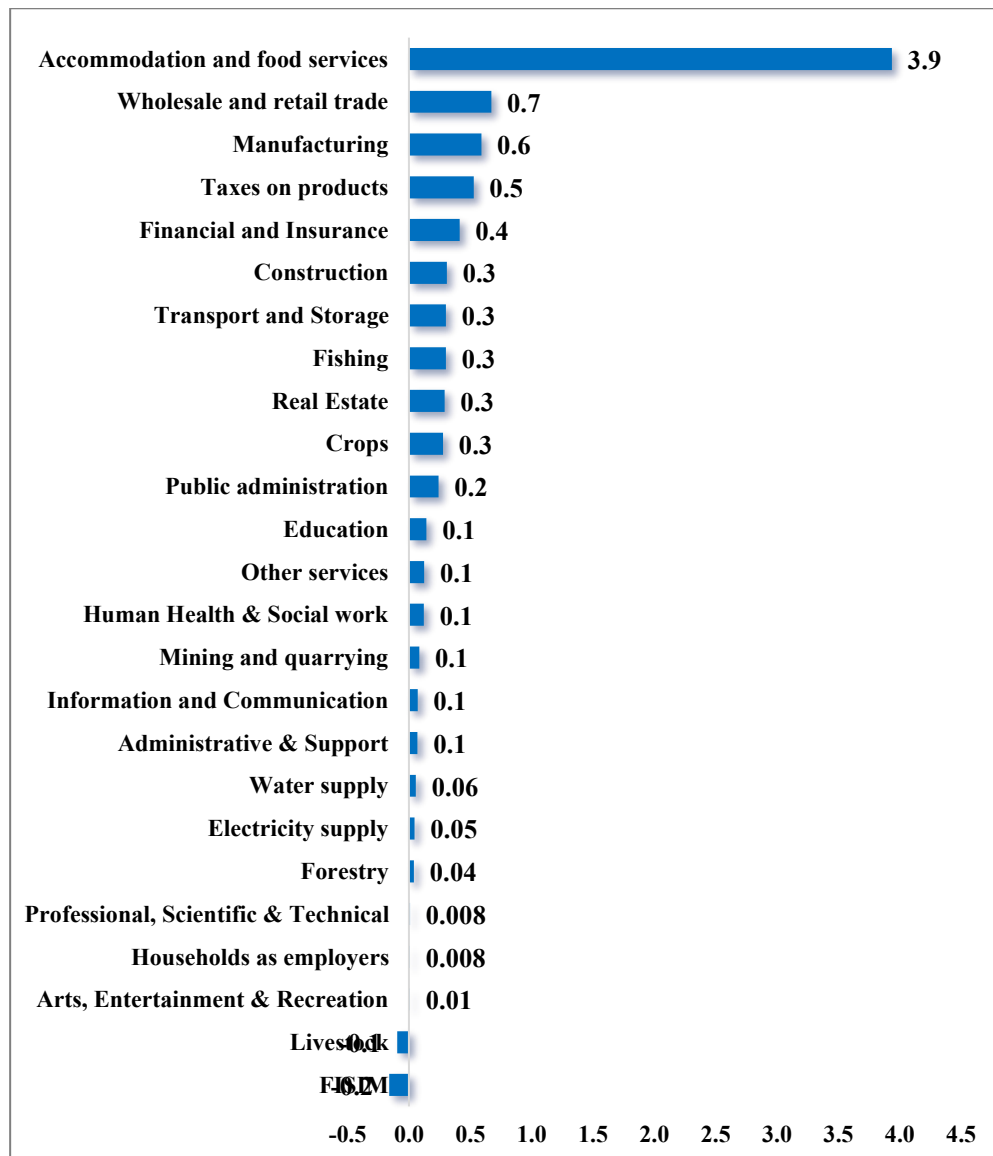
Zanzibar's Gross Domestic Product (GDP) in the fourth quarter of 2025 in volume terms increased by **8.4 percent** compared with corresponding quarter (**7.2 percent**) of 2024. The analysis of GDP growth by economic activity shows that Accommodation and Food Service Activities were the main contributors to overall GDP growth during the quarter, contributing 3.9 percentage points. This was followed by Wholesale and Retail Trade, which contributed 0.7 percentage point, and Manufacturing, which contributed 0.6 percentage points.

Other notable contributions came from Taxes of Products which contribute 0.5 percentage points, Financial and Insurance Activities which contribute 0.4 percentage points, as well as Constructions, Transport and Storage, Fishing, Real Estate and Crops each contributing 0.3 percentage points.

Relatively small contributions were recorded in Public administration (0.2 percentage points), Education (0.1 percentage points), Mining and Quarrying (0.08 percentage points), and Water Supplies (0.05 percentage points).

Overall, the results indicate that growth in GDP during this quarter was mainly driven by service-related activities, particularly accommodation and food services, trade, and taxes on manufacturing.

Growth of Main Sectors at Constant Prices

Agricultural sector increased by 2.5 percent due to an increase in yields of crops such as paddies, cassava, banana etc. and vegetables and fruits like watermelons and tomatoes, as well as an increase in fishery production.

The industrial sector also increased by 6.6 percent. This growth was primarily due to increases in manufacturing goods and mining and quarrying production.

The service sector grew by 10.9 percent compared with corresponding quarter, 2024. This growth came from crucial sectors including Accommodation and Food Services, Transport and Storage, Financial and Insurance, Other Services, Administrative & Support, Information and Communication, Public Administration, Arts, Entertainment & Recreation, Education, Human Health & Social work, Real Estate as well as Wholesale and retail trade.

Figure 2: Changes in percentage by economic activity Q4 2025 to the corresponding quarter 2024

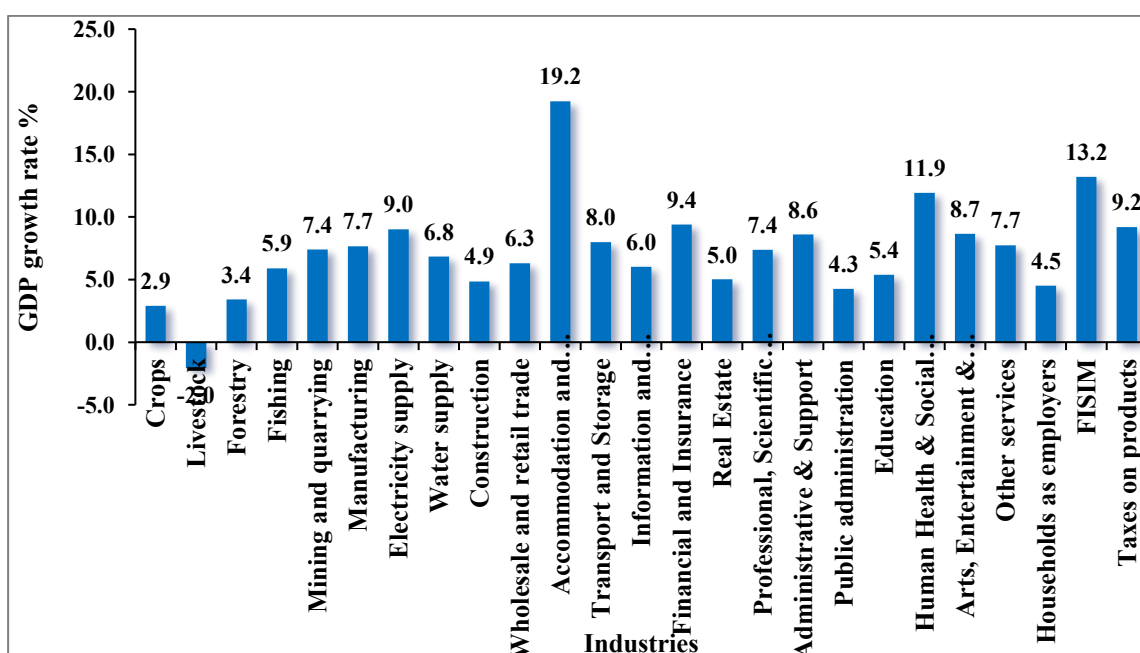


Figure 2 above shows that based on constant price, the GDP growth by economic activity indicates mixed performance across industries during this quarter. The growth observed by various economic activities where Accommodation and Food Service Activities, which increased by 19.2 percent, Taxes on Products recorded a growth of 9.2 percent, indicating increased revenue collection. Other economic activities observed are Human Health and Social Work Activities (11.9 percent), Electricity Supply (9.0 percent), Arts, Entertainment and Recreation (8.7 percent), Professional, Scientific and Technical Activities (7.4 percent), Water Supply (6.8 percent), Wholesale and Retail Trade (6.3 percent) and Fishing (5.9 percent).

Furthermore, other GDP growth registered in Public Administration (4.3 percent), Forestry (3.4 percent), and Crop Production (2.9 percent).

Performance by Main Sectors
The Agriculture, Forestry and Fishing

In Q4 2025, this sector increased by 2.5 percent compare to corresponding quarter of 2024. This is due to the increase in Fishing by 5.9 percent, Forestry 3.4 percent, and Crops 2.9 percent, while Livestock decrease by 2.0 percent.

At current prices, Agriculture, Forestry & Fishing sector was valued at TZS 422 billion in Q4 2025, accounting for about 22.3 percent to the total GVA.

Figure 3: Growth Rates of the Agriculture, Forestry & Fishing Sector, Q1_2024 – Q4_2025

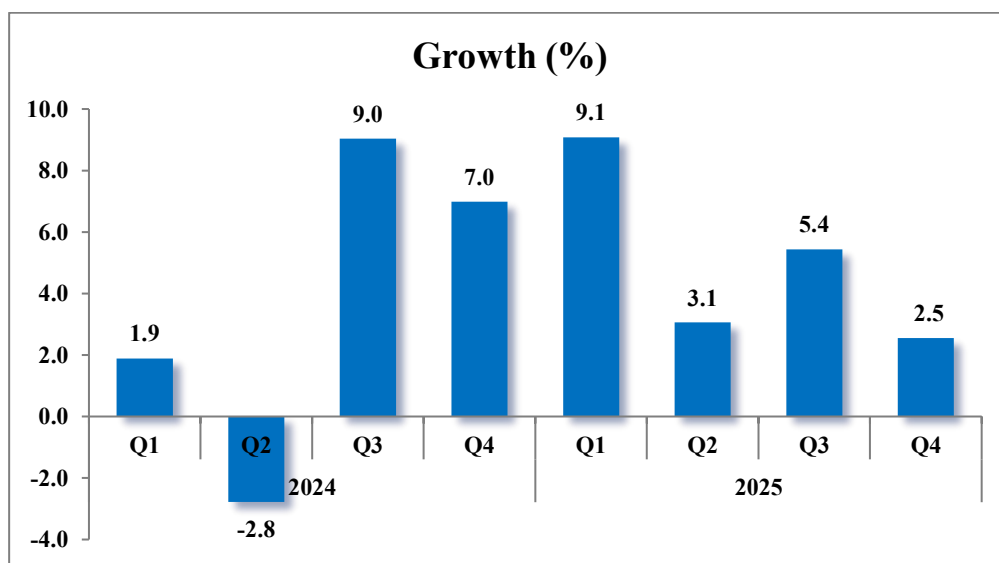

The Industrial Sector

At constant prices Industrial sector has increased by 6.6 percent in Q4_2025 compared to corresponding quarter of 2024. This was mainly attributed to the increase in Electricity Supply by 9.9 percent, followed by Manufacturing 7.7 percent, Mining and Quarrying 7.4 percent, Water Supply 6.8 percent and Construction 4.9 percent.

At current prices, this sector was valued at TZS 299 billion, contributing 15.8 percent to the total GVA.

Figure 4: Growth Rates of the Industrial Sector, Q1_2024 – Q4_2025

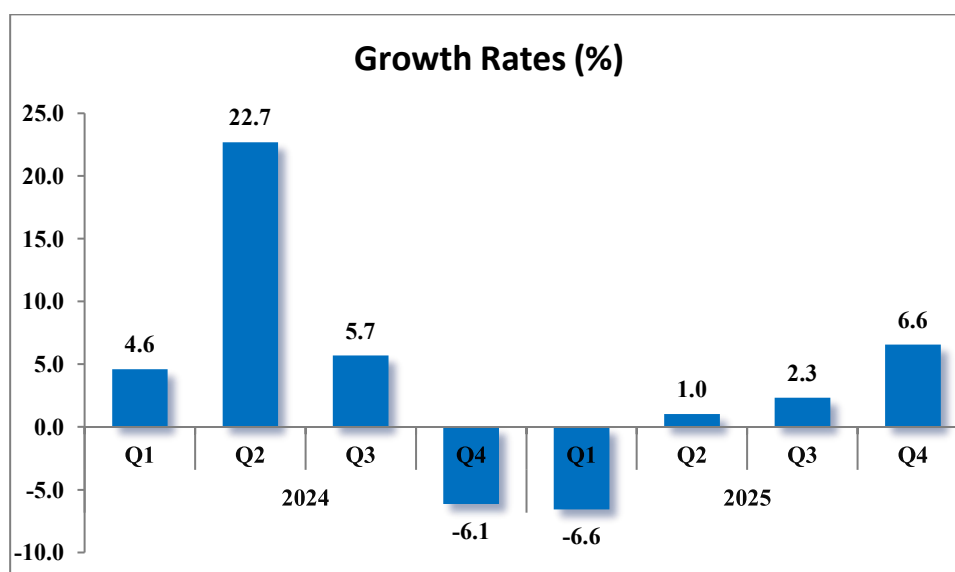

The Services Sector

At constant prices in this quarter the services sector has increased by 10.9 percent compare to corresponding quarter of 2024. The positive growth was attributed by Accommodation and Food Services by 19.2 percent, followed by Financial and Insurance 9.4 percent, Administrative & Support 8.6 percent, Transport and Storage 8.0 percent, Other Services 7.7 percent, Wholesale and retail trade 6.3 percent, etc.

At current prices, the services sector was valued at TZS 973,861 billion and contributed 51.4 per cent to the total GVA in Q4_2025.

Figure 5: Growth Rates of the Services Sector, Q1_2024 – Q4_2025

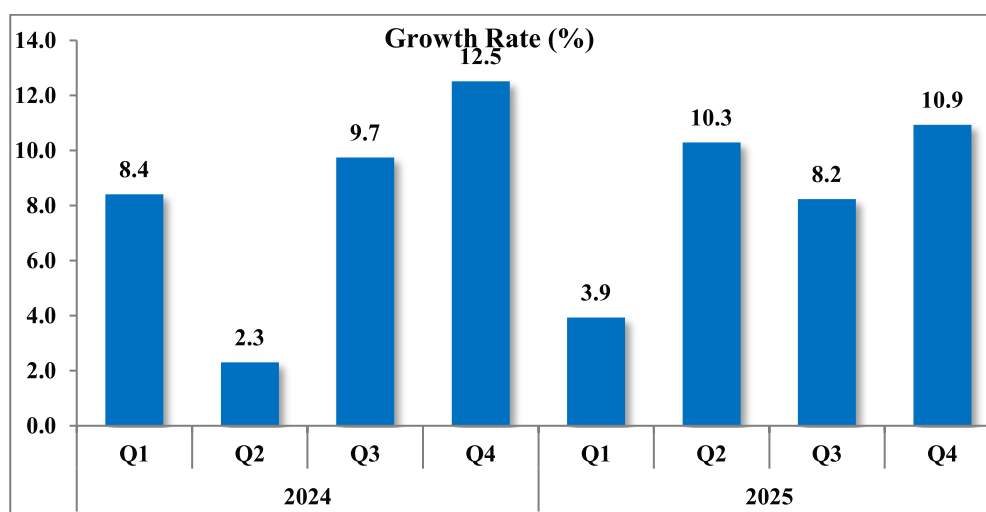

Introduction

The compilation of national accounts statistics is a dynamic process and therefore needs to adapt to reflect a variety of measures and indicators consistent with developments and structural changes in the economy over a period. It is therefore expected that revisions and updates are made to the historical series on a quarterly or annual basis as new data sources are brought into the model and as various benchmarks and assumptions are validated and updated.
