### 1. Balance of Trade

Balance of Trade showed a deficit of TZS 122,201.5 million in October 2023, increased twice compared to the corresponding month of 2022 and decreased by 7.9 percent compared to the previous month. Trade ratio decreased from 13.1 percent in September 2023 to 10.9 percent in October 2023. (Table 1).

## 2. Exports Statistics

October 2023, recorded a total exports value of TZS 14,994.5 million, decreased by 39.1 percent compared to October 2022 and by 25.0 percent compared to previous month (September 2023). Food and live animals contributed 89.4 percent (TZS 13,399.2 million) of the total exports as seen in table 2.



# 3. Exports by Top Five Partner in October 2023

The top five trading partners for exported goods in the October 2023 accounted 85.8 percent of the total value of exported goods. Major export destination was Singapore that accounted 58.4 percent (TZS 8,751.6 million) of the total export (Figure 1).

### 4. Imports Statistics

Month of October 2023 recorded a total import value of TZS 137,196.0, which increased by 60.1 percent compared to October 2022 and decreased by 10.1 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 51.4 percent (TZS 70,585.4 million) of the total import value followed by Food and live animals section (16.6 percent). The performances of other sections are as shown in table 3.

### 5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for October 2023 was TZS 35,724.3 million, which increased by 64.1 percent compared to corresponding month and by 12.4 percent compared to previous month. Imports value of capital goods was TZS 21,502.5 million, which increased by 19.7 percent compared with the corresponding month and decreased by 64.2 percent compared with the previous month. Imported value of intermediary goods was TZS 79,969.2 million, which increased by 74.0 percent compared to the corresponding month of 2022 and by 31.7 percent compared to previous month. (Table 4).



## 6. Imports by Top Five Partner in October 2023

The top five trading partners for imported goods in the October 2023 contributed 81.5 percent of the total import. Imports were mainly from United Arab Emirates (54.3 percent, TZS 74,475.1 million).
