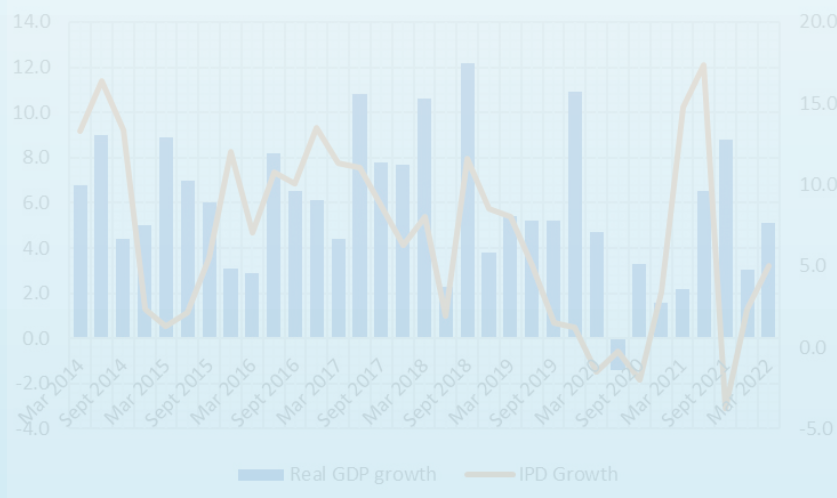

Overview of Zanzibar Economy

Gross domestic Product (GDP) went up by 5.1 percent in the March quarter 2022. Total GDP in real terms amounted to 853,664 TZS Million. The favorable performance in the period reflects the increasing of Fishing activities, Construction, Mining and quarrying and tourism related activities such as Accommodation & Food Services as being implemented major developments in the period which impacted positively on the performance of the industries.

Chart 1 displays the growth rates from March 2014 to March 2022 as measured by the percentage change in real GDP on the same quarter of the previous year (y-o-y) and GDP at constant 2015 prices. As revealed by the chart, quarterly y-o-y growth rates were positive in the last thirty three consecutive quarters, ranging from 6.8% to 5.1% from March 2014 to March 2022. But as noted, real value added in the period under review was 5.1% (March 2022) higher than its value in the previous (December 2021). In this period, were mainly driven by Construction Accommodation and food services (share of 17.1 percent), Livestock (share of 12.3 percent) and Construction (share of 11.6 percent).

Chart 1: Total GDP at constant 2015 prices and Growth in quarterly GDP

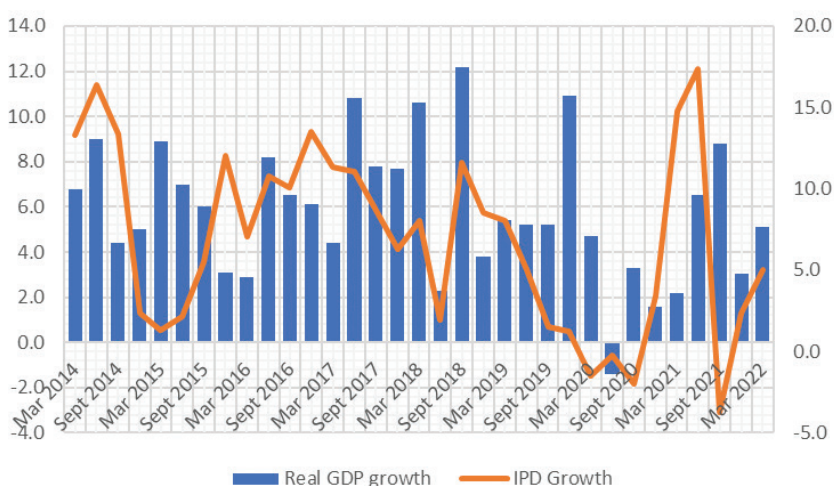
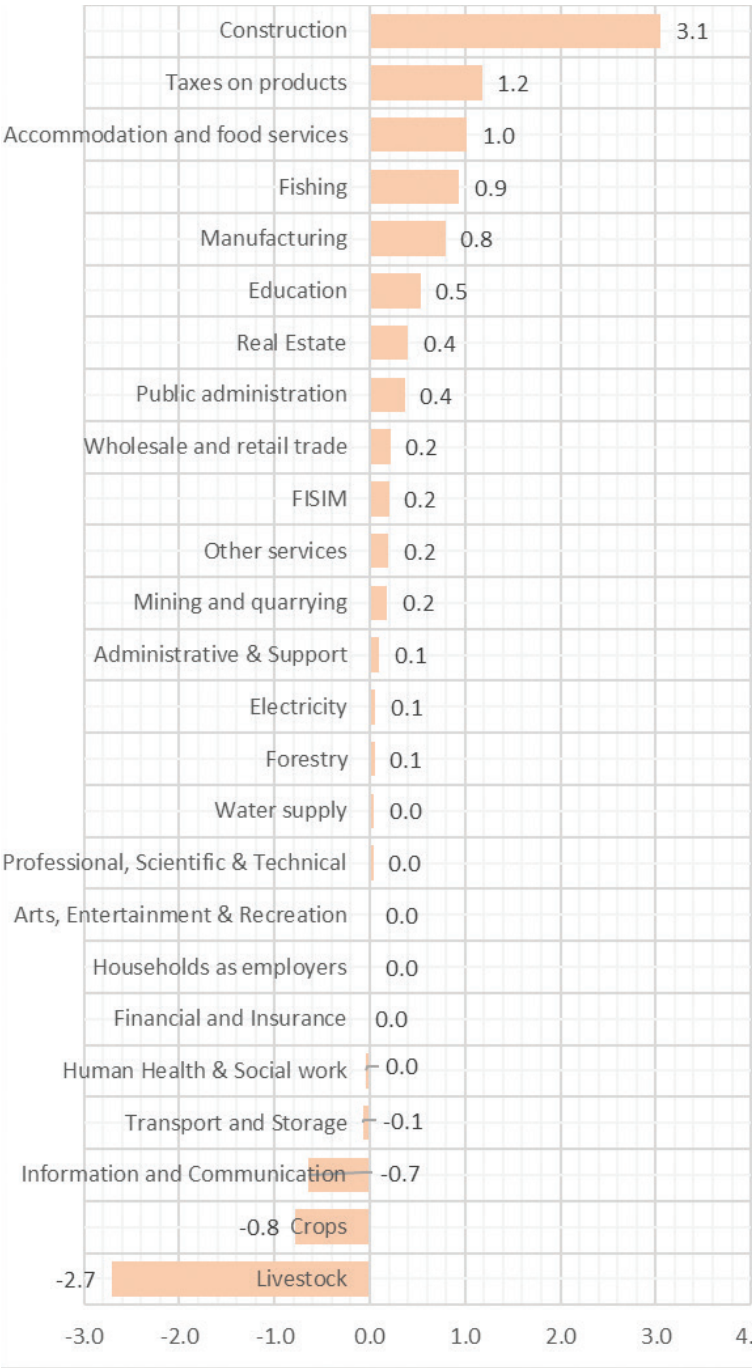


Chart 2 shows the percentage – point contribution of each industry to the overall growth of 5.1 percent in the quarter ended March 2022. The positive contributors to the growth rate were Construction (3.1 percent point), Accommodation and Food services (1.0 percentage points), Fishing (0.9 percentage points), Manufacturing (0.8 percentage points), Education (0.5 percentage points each), Real Estate and Public Administration (0.4 percentage points each).

On the other hand, industries that contributed negatively as shown in Chart 2 were Livestock (2.7 percentage points), Crops (0.1 percentage point), information communication (0.7 percentage point) and Transport and Storage is 0.1 percentage point.

GDP levels (Nominal or Current Prices):

Total GDP for the March 2022 quarter in nominal terms stood at 1,377,908 TZS million, climbing 10.4 percent compared to corresponding quarter of 2021. Livestock had the biggest percentage-changes of 44.4 percent in value added at current prices with a contribution of 5.2.

Chart 3: Composition of GDP, March 2022 Quarter

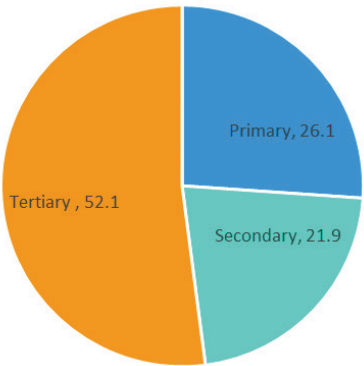


Chart 3 shows the composition of GDP at current prices for March 2022 quarter, categorized into the three main broad sectors of the economy, Primary Sector, Secondary Sector and Tertiary Sector (Services Sector).

Tertiary sector remains the largest comprising a total share of 52.1 percent of aggregate GDP, decreasing by 7.6 percent compared to its share in the same 2021 quarter. Secondary sector recorded a share of 21.9 percent increasing its share from 21.8 percent compared to the same quarter 2022. And primary sector recorded a total share of 26.1 percent, increased by 7.4 percent compared to the 2021 quarter.

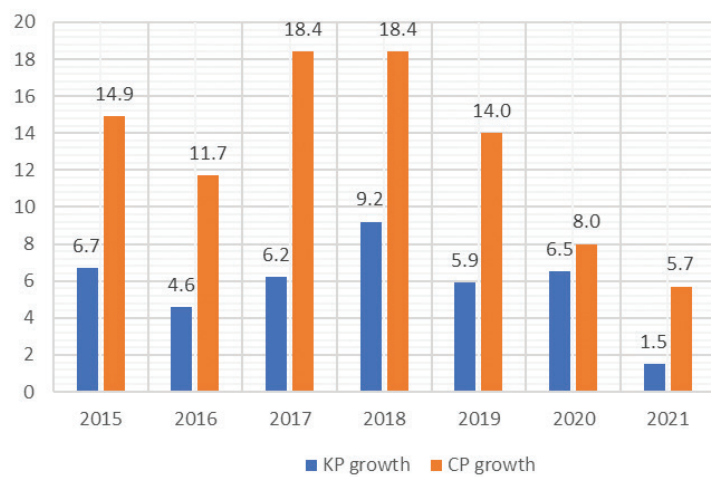
Twelve Months Review (April 2021— March 2022):

At constant 2015 prices (real terms), GDP stood at 3,332,565 million recording an increase of 5.8 percent compared to the 12 months period ended March 2021. This percentage increase was evident that favorable economic performance attributed by industries such as Construction (contributed 1.9 percentage points), Livestock (contributed 1.0 percentage points), Wholesale and retail trade

(contributed 0.9 percentage points) followed by Real Estate, Manufacturing, Transport and Storage (contributed 0.4 percentage points each).

Chart 4 shows the growth rates for the 12 months period ending April for the years 2014/15 to March 2021/22. As shown by the chart, economic activities in the 12 months period April 2014/15 to March 2021/22 have been steadily showing favorable performances for the 12 months period ending March 2022.

As indicated by the chart above there was consecutive positive growth at 2015 constant prices since period ending March 2015 to the same period of 2022. The pick has experience on 2017 and 2018 compared to other years. This contribution highly attributed by volume of cloves production in Zanzibar.

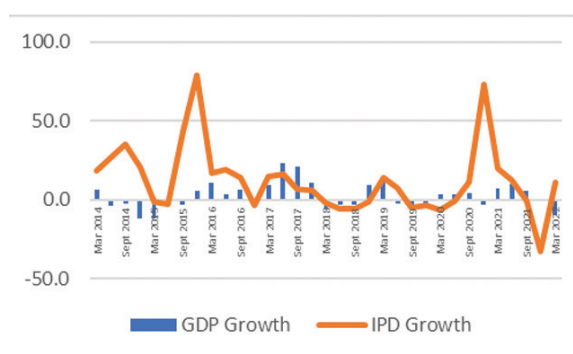

The Crops sub sector generated a total value added in real terms of **60,779 TZS** million in the period under review. During March 2022 quarter, the activity declined by **9.5** percent and also grew by 0.7 percent when compared to December 2021 quarter. The industry contributed a negative **0.8** percentage points to overall GDP growth across the March quarter 2022.

The current prices in March quarter 2022 declined by **32.4** (q-o-q). Again there was a positive performance y-o-y of 0.7 percent for similar quarter 2021.

Mar 2014 – Mar 2022**

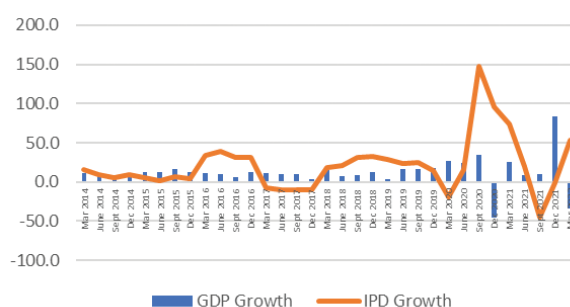

Livestock recorded a total value added of **41,897 TZS** million in constant prices for the period under review.

This makes the negative performance of **34.4** percent y-o-y for March quarter 2022 compared to the corresponding quarter of 2021. The industry contributed a negative **0.8** percentage-point contribution of growth to the overall GDP. The current price value added marked **169,812 TZS** for March performance of **0.6** percent (y-o-y).

Chart 6: Percentage change in Livestocks; Mar 2014 – Mar 2022

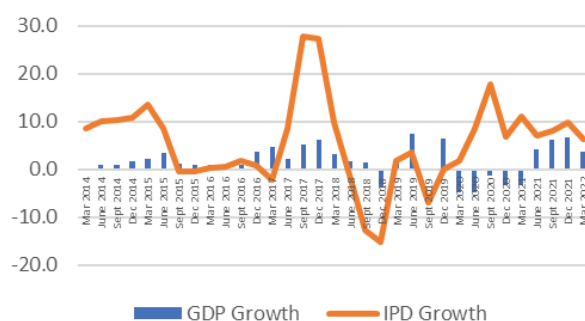

Forestry registered a total value added of **11,222 TZS** million in constant prices for the period under review. The industry contributed positively to the overall growth rate with **0.1** percentage points. The favorable performance by the industry was in line with the increased of volume of forestry product.

Current prices marked the value added of **14,988 TZS** million that result a positive growth of **10.3** percent (y-o-y). This activity accounts for **1.1** percent share to total GDP.

March 2014–March 2022**

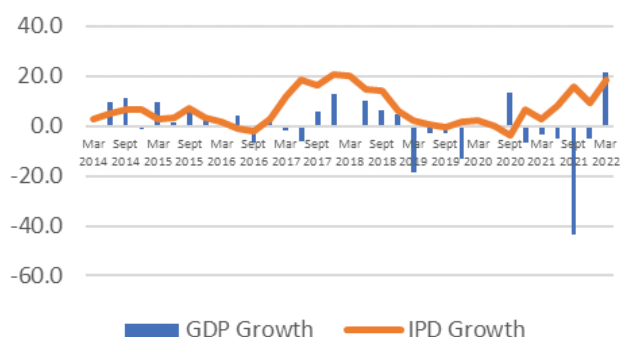

Fishing recorded a total value added of **42,586 TZS** million in constant prices for the period under review. The volume of fish catches led to y-o-y change of positive performance of **21.7** percent for the same quarter 2021. The change from December 2021 quarter recorded a negative growth of **4.8** percent.

The value added at current prices registered **71,410 TZS** million for the March quarter 2022 (y-o-y) that marked **44.4** percent of growth. The industry account for **5.2** percent share to total GDP.

Mar 2014– March 2022**

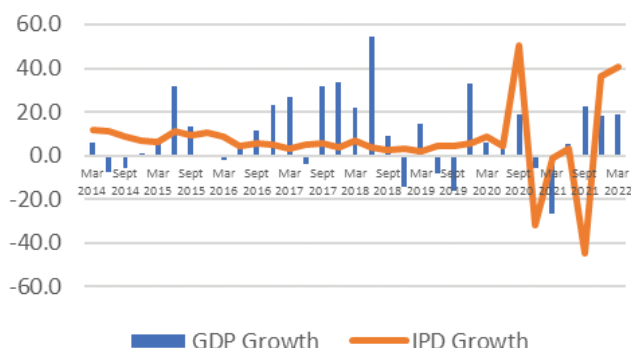

Mining and Quarrying registered a total value added of **9,032 TZS** million in constant prices for the period under review. The industry contributed positively to the real growth rate with **0.2** percentage points for March 2022 quarter.

The positive performance of **19.1** percent (y-o-y) shown by the industry was in line with the increases of volume of quarrying products within Zanzibar. However, the industry accounts for positive performance of **67.2** percent (y-o-y) at current prices that marked **15,909 TZS** value added. Changes from December 2021 quarter experience a positive growth of **60.9** percent (q-o-q).

Mar 2014– March 2022**

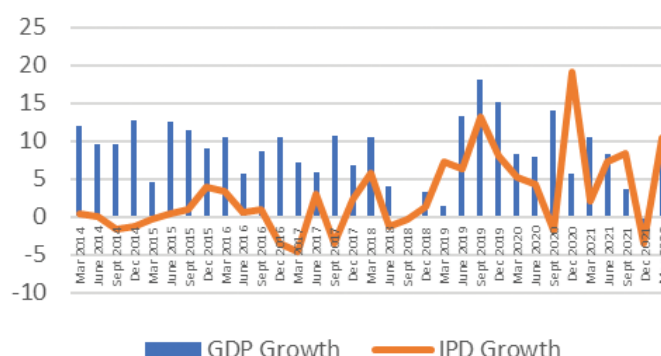

Manufacturing marked a total value added of **76,685 TZS** million in real term for the period under review. The industry contributed positively to the overall real growth with **0.8** percentage points for March quarter 2022. The industry observed a positive performance of **9.2** percent (y-o-y).

Current prices registered a positive growth of **20.5** percent for March 2022 quarter (y-o-y) compared to March 2021. A negative growth rate of **6.9** percent from December quarter 2021 has been observed.

Mar 2014– Mar 2022**

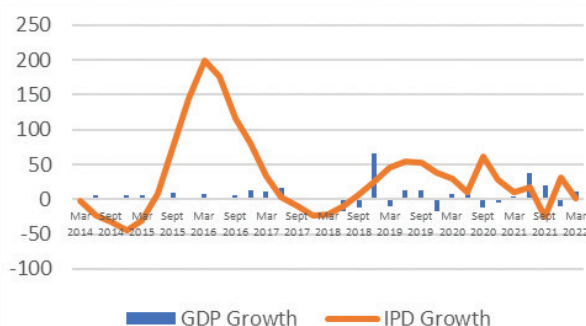

Electricity Supply value added at constant prices stood at **4,298 TZS** million as a result of **11.9** positive growth for March 2022 quarter compared to same quarter of previous year. Moreover, this quarter revealed a negative growth of **9.6** percent compared to Dec 2021 quarter.

In nominal term the industry marked **18,540 TZS** million in March 2022 quarter that registered a share of **13.5** percent to total GDP.

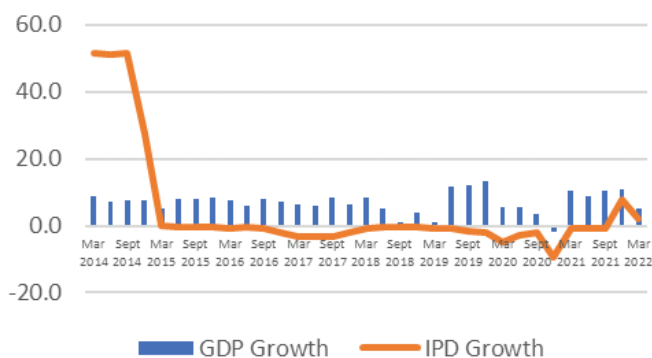
**Chart 11: Percentage change in Electricity Supply;

Water was among the industries that have shown a positive performance. As it stood, the industry recorded a **7,850 TZS** million in value added in real terms for the period under review. This was **5.0** percent change the value added it generated in March quarter 2022, and positive **10.7** percent compared to the December 2021 quarter.

Mar 2014– Mar 2022**



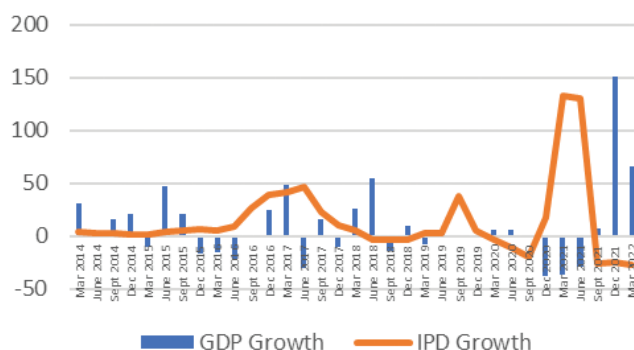

At constant 2015 prices, Construction industry registered a positive **65.6** percent compared to its value added in March 2022. The performance by the industry was consistent with the completion of major construction projects activities performed in the period under review.

Furthermore, when compared to Dec 2021, again the industry value added grew further by **151.1** percent.

In nominal term the industry marked **159,587 TZS** million in March 2022 quarter that registered an increase of **21.1** percent compared to March 2021 quarter.

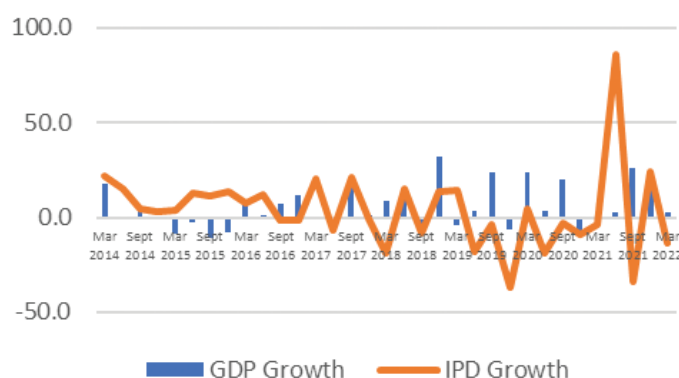
**Chart 13: Percentage change in Construction;

Wholesale and retail Trade industry generated a total value added of **60,393 TZS** million at constant 2015 prices. In December 2021 quarter, the industry recorded a value added of **62,092 TZS** million; and a **58,645 TZS** million value added in March quarter 2021. Value added increased by **19.6** percent (q-o-q) and grew up by **3.0** percent (y-o-y). The industry was one among the positive contributors to the overall GDP growth, registering a total share of **4.3** percent and a contribution of positive **0.2** percentage points to overall growth.

Chart 14: Percentage change in Wholesale and Retail Price; Mar 2014– Mar 2022

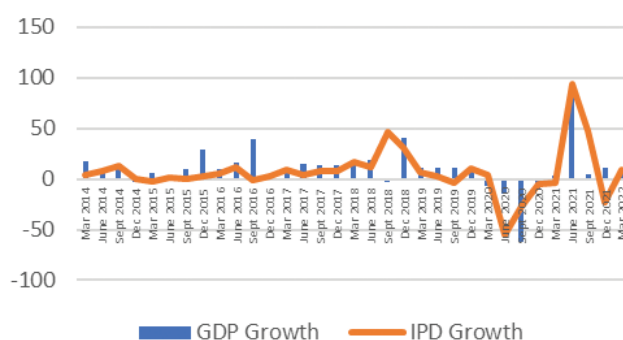

Accommodation and Food Services recorded a total value added of **154,594 TZS** million at constant 2015 prices. Compared to its total value added it recorded in the same quarter of the previous year, the industry went up by **5.6** percent. When compared to Dec 2021, the industry increased by **10.6** percent.

Current prices performed a positive y-o-y growth rate of **15.9** percent which accounts for total value added of **235,876 TZS** million. Change from December quarter 2021 also decreased by **14.7** percent.

Chart 15: Percentage change in Accommodation and Food Services; Mar 2014– Mar 2022



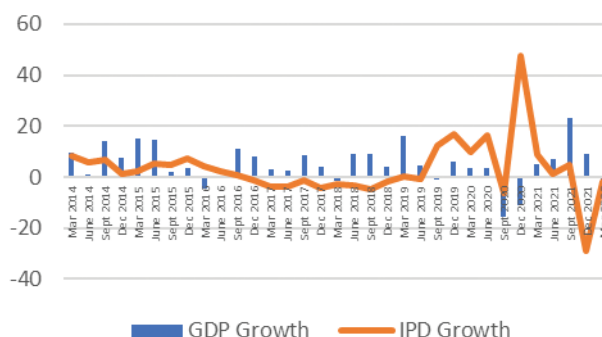

Transport and Storage sector accumulated a total value added of **32,415 TZS** million in real terms. This was a decreases of **1.8** percent in March 2022 quarter (y-o-y). The sector contributed negative value of **0.1** percentage-points to overall growth GDP.

When compared to the previous quarter (December 2021) value added increased by **8.8** percent.

Compared to December quarter of 2021, there was a deceased of value added by **22.7** percent at current prices.

Chart 16: Percentage change in Transport and Storage; Mar 2014– Mar 2022

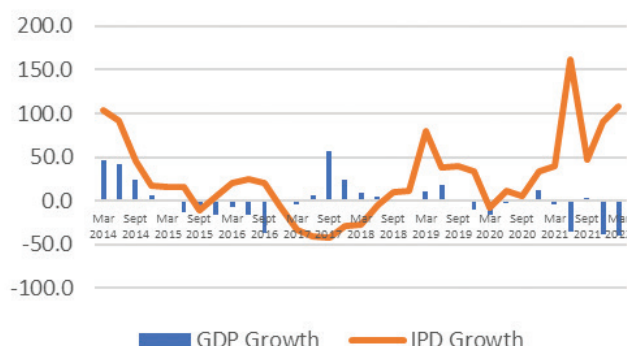

The total value added of Communication in real terms amounted to **7,844 TZS** million. This was translated into a decreased of **40.3** percent compared to similar quarter of 2022. The industry took out a total share of **1.6** percent of overall GDP.

In current prices, the industry value added stood at **21,671 TZS** million and grew by **24.4** percent on a y-o-y basis. The sector's performance in the period reflects the increase of sales of airtime in that period under review.

Chart 17: Percentage change in Information and Communication; Mar 2014– Marc 2022

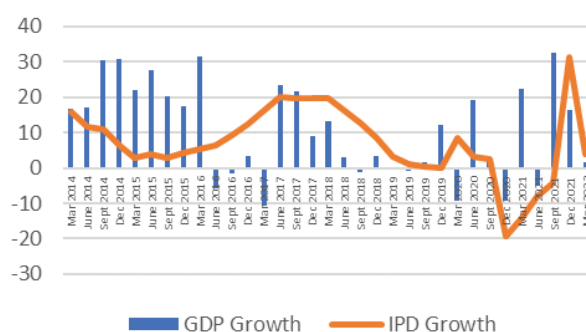

In the March 2021 quarter, Financial and Insurance recorded a total value added in real terms of **27,264 TZS** million; this was a positive **1.4** percentage change compared to the same period of the previous year. When compared to the previous quarter, the industry increased by **16.4** percent.

At Current prices, the industry recorded a total value added of **39,151 TZS** which marked an increase of **5.3** percent (y-o-y).

Mar 2014– Mar 2022**



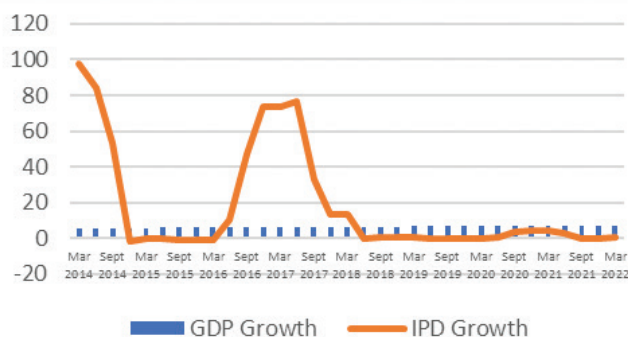

At constant 2015 prices, Real Estate value added stood at **48,926 TZS** million in the March quarter of 2022. The industry's performance increased by **7.0** percent when compared to the same period last year, contributing a **0.4** percentage points to the overall performance. The increase in value added reflects the increasing demand by the real estate activities.

When compared to the December 2021 quarter, value added went up by **6.9** percent.

In nominal term the value added stood at **99,288 TZS** million that reflects **7.0** percent y-o-y positive growth.

Mar 2014– Mar 2022**



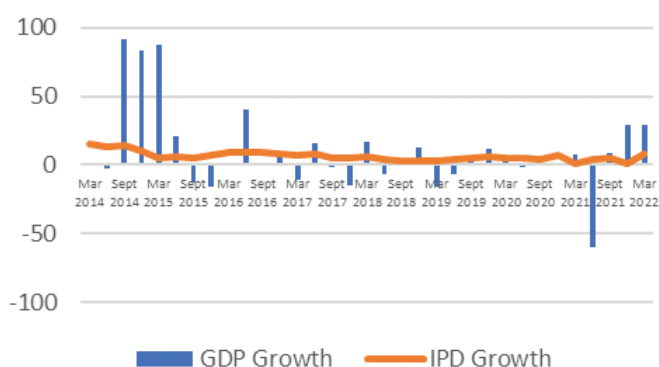

In real terms the value added for professional, scientific and technical amounted to **1,339 TZS** million. The activity grew by **29.0** percent during March 2022 quarter.

In current prices, the industry value added stood at **1,907 TZS** million, went up by **39.6** percent on a y-o-y basis.

The share for the industry remained as **0.1** percent for March 2022 quarter.

Chart 20: Percentage change in Professional, Scientific & Technical; Mar 2014– Mar 2022

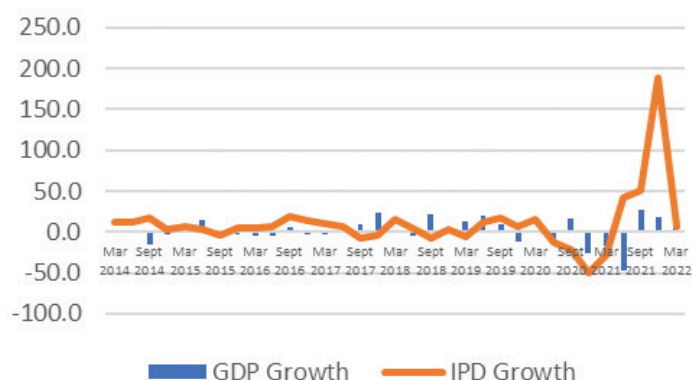

Value added for Administrative and support at constant prices stood at **6,540 TZS** millions. This was **14.0** percent higher compared to corresponding quarter of 2021. The December quarter went up by **18.7** on q-o-q basis.

Current price has shown an increase of the value added by **21.6** percent on y-o-y basis and increased by **243.8** percent on q-o-q basis in Mar 2022 quarter.

Mar 2014– Mar 2022**

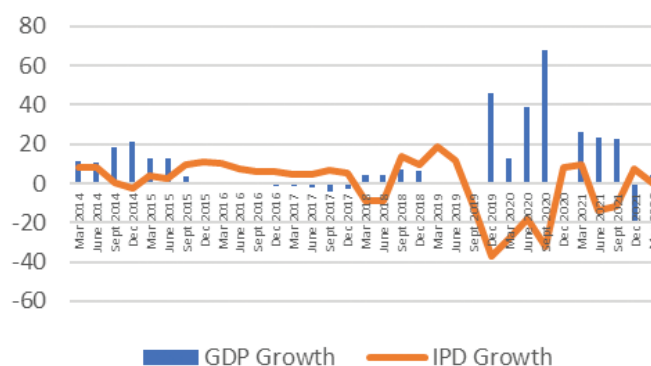

The value added for public administration amounted to **69,327 TZS** in real terms for March quarter 2022. The change in value added from March 2022 to same quarter of 2021 increased by **4.5** percent on y-o-y basis, and decreased by **19.1** percent on q-o-q basis. The industry contributed **0.4** percentage point to overall GDP growth.

In nominal terms the value added registered **66,377 TZS** million as a result of an increase of **5.1** percent on y-o-y basis and decreased by **13.0** percent compared to December quarter, 2021.

Chart 22: Percentage change in Public Administration; Mar 2014– Mar 2022

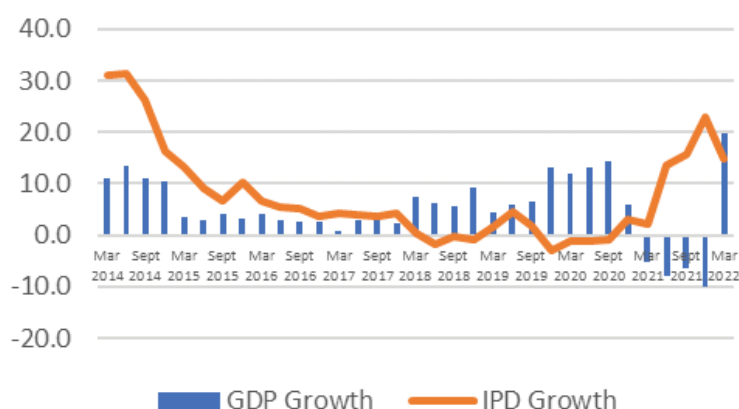

The Education sector generated a total value added in real terms of **26,032 TZS** million in the period under review. Compared to the March 2021 quarter, the activity went up by **19.9** percent, and decreased by **9.9** percent when compared to December 2021 quarter. The industry contributed a positive **0.5** percentage points to overall GDP growth.

The current prices registered a positive performance of **10.7** percent from December quarter 2021 (q-o-q). When compared to March 2022 quarter the value added increased by **37.8** percent on y-o-y basis. The share marked **2.5** percent for the March 2022.

For the period under review, the industry generated a value added in constant prices of **8,955 TZS** million, this was **3.2** percent lower than the value added it produced in the March 2022 quarter to the same quarter of the previous year.

Nominal terms the value added for March 2022 quarter marked a **10,242 TZS** million, this was a decline of **16.5** percent as for Same quarter 2021. In December 2021 quarter the share amounted to **0.7** percent.

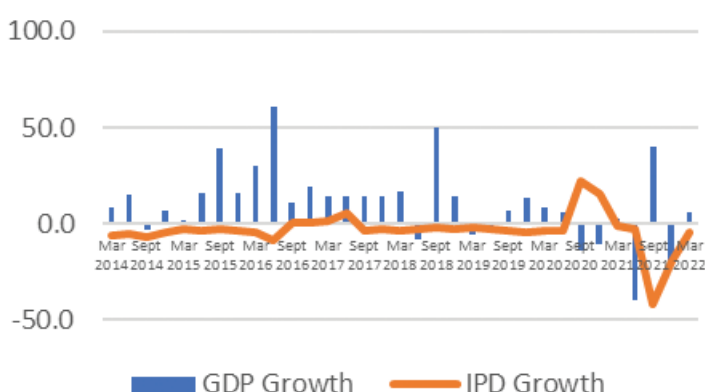
Chart 24: Percentage change in Human Health and Social Work; Mar 2014– Mar 2022

Arts, Entertainment and Recreation industry registered a total value added of **958 TZS** million at constant 2015 prices for March quarter 2022. In December 2021 quarter, the industry recorded a value added of **730 TZS** million; and a **908 TZS** million value added in March quarter 2021. For march 2022 the value added went up by **5.5** percent and decreased by **18.7** percent in the respective periods. The industry accounted for **0.1** percent share to total GDP.

At constant 2015 prices, Other Services industry amounted **15,050 TZS** million value added for March 2022 quarter. This translated as **11.5** percent higher than same 2021 quarter whereas, December 2021 quarter marked a negative performance of **5.8** percent on q-o-q basis.

Current prices registered to **20,774 TZS** million for March 2022 quarter which reflected the positive performance of **24.4** percent on y-o-y basis. Compared to December 2021 quarter the result has shown the negative performance that marked **17.8** (q-o-q). The December quarter, this industry showed **1.4** percent of share to total GDP.

Mar 2014 – Mar 2022**

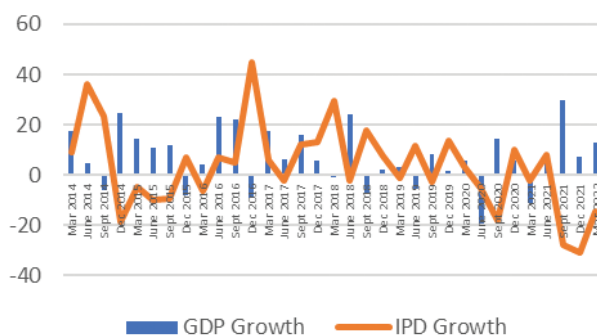

The Taxes on Products generated a total value added in real terms of **82,491 TZS** million in the period under review. The value added for March 2022 quarter was **13.1** higher than the value added for the same quarter of the previous year. Compared to the December 2021 quarter, the activity again went up by **7.4** percent.

The current prices registered a negative performance of **3.6** percent from March quarter 2022 (y-o-y). When compared to December 2021 quarter the value added decreased by **25.8** percent on q-o-q basis..

Introduction

The compilation of national accounts statistics is a dynamic process, and therefore needs to adapt to reflect a variety of measures and indicators consistent with developments and structural changes in the economy over a period of time. It is therefore expected that revisions and updates are made to the historical series on a quarterly or annual basis as new data sources are brought into the model and as various benchmarks and assumptions are validated and updated.

This quarterly report is the 15th published by the Office of the Chief Government Statistician of the new quarterly series of GDP estimates at constant 2015 prices. This report is an ongoing publication and can also be downloaded from our website www.ocgs.go.tz.
