1. Balance of Trade

Balance of Trade showed a deficit of TZS 86,518.3 million in March 2025, decreased by 21.7 percent compared to the corresponding month of 2024 and by 33.4 percent compared to the previous month. The trade ratio for March 2025 decreased to 2.0 from 2.5 percent in February 2025 and from 4.8 percent in March 2024 (Table 1).

2. Exports Statistics

March 2025, recorded a total exports value of TZS 1,733.4 million, decreased by 69.1 percent compared to March 2024 and by 47.6 percent compared to previous month (February 2025). Food and live animals contributed 33.8 percent (TZS 585.8 million) of the total exports as seen in table 2.



3. Exports by Top Five Partner in March 2025

The top five trading partners for exported goods in the March 2025 accounted 86.7 percent of the total value of exported goods. Major export destination was Kenya that accounted 27.1 percent (TZS 469.0 million) of the total export (Figure 1).

4. Imports Statistics

Month of March 2025 recorded a total import value of TZS 88,251.7 million, which decreased by 24.0 percent compared to March 2024 and increased by 33.7 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 87.3 percent (TZS 77,081.6 million) of the total import value followed by Machinery and transport equipment section 3.7 percent (TZS 3,284.0). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for March 2025 was TZS 4,301.6 million, which decreased by 87.2 percent compared to the corresponding month 2024 and by 84.8 percent compared to previous month. Imports value of capital goods was TZS 4,552.7 million which decreased by 80.3 percent compared corresponding month and by 77.7 percent compared the previous month. Imported value of intermediary goods was TZS 79,397.4 million, which increased by 33.7 percent compared to the corresponding month of 2024 and decreased by 6.1 percent compared to previous month. 
