1. Balance of Trade

Balance of Trade showed a deficit of TZS 110,430.2 million in March 2024, increased by 3.8 percent compared to the corresponding month of 2023 and by 7.1 percent compared to the previous month. Trade ratio for March 2024 is 4.8, increased from 6.1 percent in February 2023 and from 9.2 percent for previous month. (Table 1).

2. Exports Statistics

March 2024, recorded a total exports value of TZS 5,618.1 million, decreased by 18.3 percent compared to March 2023 and by 46.1 percent compared to previous month (February 2024). Food and live animals contributed 89.3 percent (TZS 5,016.2 million) of the total exports as seen in table 2.



3. Exports by Top Five Partner in March 2024

The top five trading partners for exported goods in the March 2024 accounted 79.8 percent of the total value of exported goods. Major export destination was India that accounted 45.3 percent (TZS 2,544.5 million) of the total export (Figure 1).

4. Imports Statistics

Month of March 2024 recorded a total import value of TZS 116,048.4 which increased by 2.4 percent compared to March 2023 and by 2.3 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 43.1 percent (TZS 50,008.6 million) of the total import value followed Food and live animals section (20.5 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for March 2023 was TZS 33,490.6 million, which increased by 47.3 percent compared to corresponding month and by 76.1 percent compared to previous month. Imports value of capital goods was TZS 23,165.1 million, which increased by 52.5 percent compared with the corresponding month and by 5.5 percent compared with the previous month. Imported value of intermediary goods was TZS 59,392.6 million, which decreased by 21.2 percent compared to the corresponding month of 2023 and by 18.1 percent compared to previous month. (Table 4).


