1. Balance of Trade

Balance of Trade showed a deficit of TZS 128,565.1 million in April 2024, increased by 16.1 percent compared to the corresponding month of 2023 and by 16.4 percent compared to the previous month. Trade ratio for April 2024 is 3.5, decreased from 4.3 percent in March 2023 and from 4.8 percent for previous month. (Table 1).

## 2. Exports Statistics

April 2024, recorded a total exports value of TZS 4,674.2 million, decreased by 6.6 percent compared to April 2023 and by 16.8 percent compared to previous month (March 2024). Food and live animals contributed 93.5 percent (TZS 4,368.3 million) of the total exports as seen in table 2.

## 3. Exports by Top Five Partner in April 2024

The top five trading partners for exported goods in the April 2024 accounted 71.6 percent of the total value of exported goods. Major export destination was India that accounted 26.8 percent (TZS 1,253.8 million) of the total export (Figure 1).

## 4. Imports Statistics

Month of April 2024 recorded a total import value of TZS 133,239.2 which increased by 15.1 percent compared to April 2023 and by 14.8 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 55.9 percent (TZS $74,447.5$ million) of the total import value followed Food and live animals section (12.3 percent). The performances of other sections are as shown in table 3.

## 5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for April 2023 was TZS 15,861.3 million, which decreased by 34.8 percent compared to corresponding month and by 8.5 percent compared to previous month. Imports value of capital goods was TZS 15,861.3 million, which decreased by 25.0 percent compared with the corresponding month and by 31.5 percent compared with the previous month. Imported value of intermediary goods was TZS $86,734.3$ million, which increased by 82.2 percent compared to the corresponding month of 2023 and by 46.0 percent compared to previous month.
