

# MONTHLY EXTERNAL MERCHANDISE TRADE STATISTICS

SEPTEMBER, 2023

## 1. Balance of Trade

Balance of Trade showed a deficit of TZS 132,652.2 million in September 2023, increased by 58.5 percent compared to the corresponding month of 2022 and by 21.1 percent compared to the previous month. Trade ratio increased from 5.4 percent in August 2023 to 13.1 percent in September 2023. (Table 1).

## 2. Exports Statistics

September 2023, recorded a total exports value of TZS 19,995.1 million, decreased by 27.5 percent compared to September 2022 and increased by more than hundred percent compared to previous month (August 2023). Food and live animals contributed 57.5 percent (TZS 11,498.7 million) of the total exports as seen in table 2.

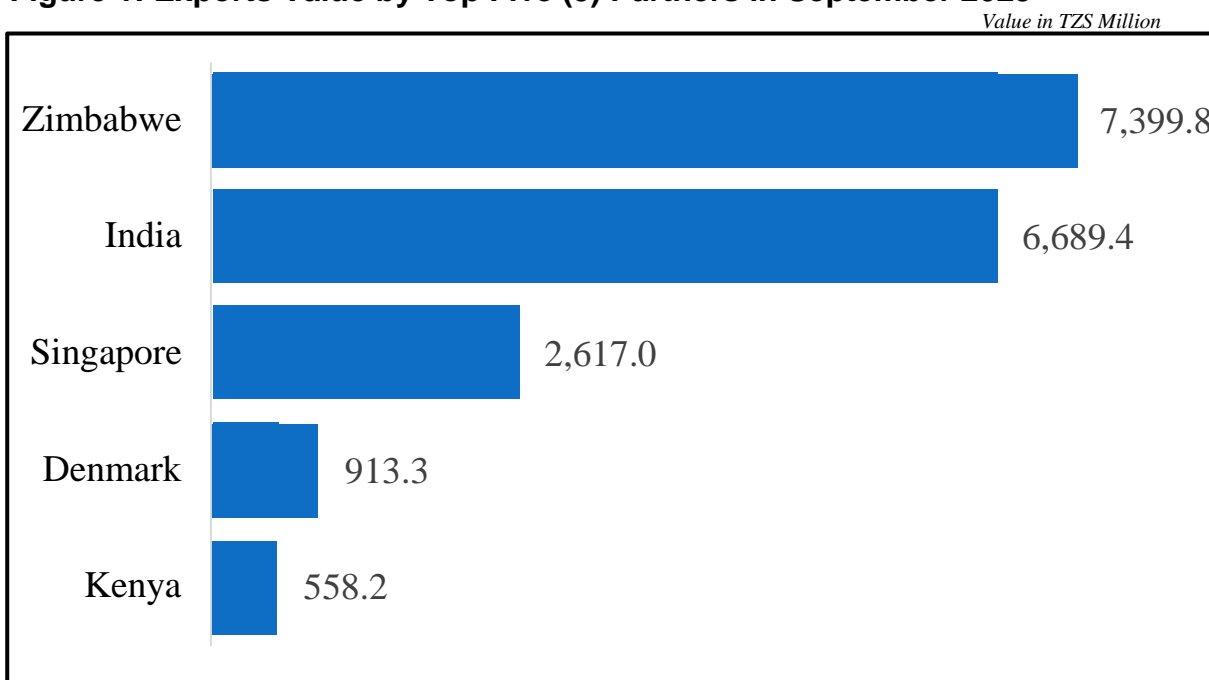

### 3. Exports by Top Five Partner in September 2023

The top five trading partners for exported goods in the September 2023 accounted 90.9 percent of the total value of exported goods. Major export destination was Zimbabwe that accounted 37.0 percent (TZS 7,399.8 million) of the total export (Figure 1).

#### 4. Imports Statistics

Month of September 2023 recorded a total import value of TZS 152,647.3 million, which increased by 37.2 percent compared to September 2022 and by 31.0 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 31.4 percent (TZS 47,862.6 million) of the total import value followed by Machinery and transport equipment section (29.6 percent). The performances of other sections are as shown in table 3.

#### 5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for September 2023 was TZS 31,774.2 million, which decreased by 6.5 percent compared to corresponding month and increased by 0.8 percent compared to previous month. Imports value of capital goods was TZS 60,145.3 million, which increased by more than hundred percent compared with the corresponding and the previous month. Imported value of intermediary goods was TZS 60,727.7 million, which increased by 12.2 percent compared to the corresponding month of 2022 and decreased by 3.8 percent compared to previous month. 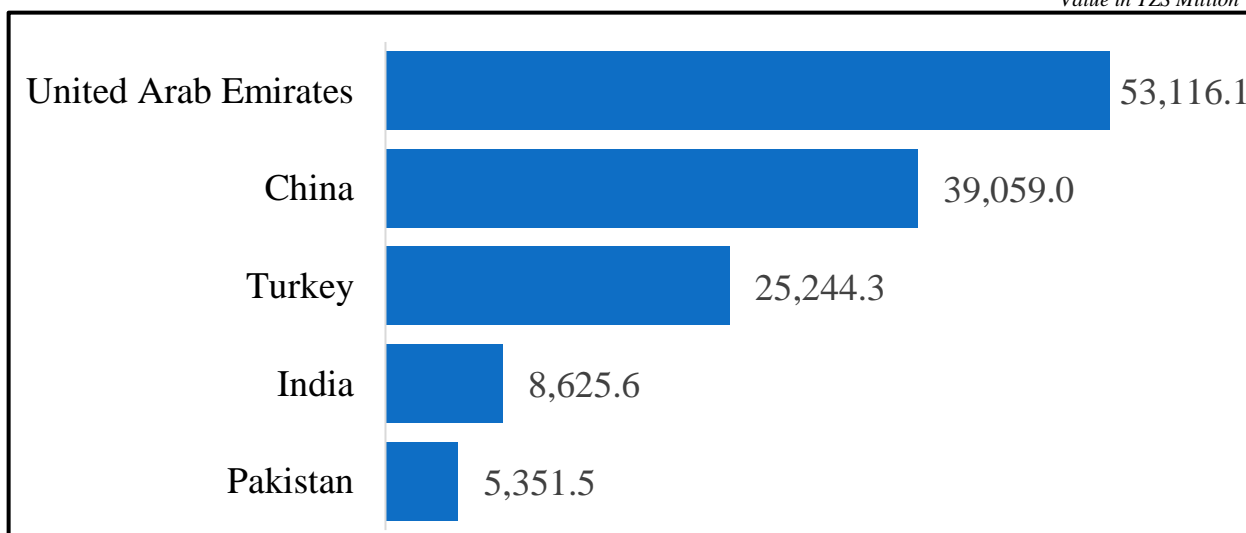
