MONTHLY EXTERNAL MERCHANDISE TRADE STATISTICS

JUNE 2022

1. Balance of Trade

Balance of Trade showed a deficit of TZS 99,017.2 million in June 2022, increased by 40.0 percent compared to the corresponding month of 2021 and by 22.2 percent compared with the previous month. Trade ratio decreased from 4.8 percent in May 2022 to 3.3 percent in June 2022. (Table 1).

2. Exports Statistics

June 2022, recorded a total exports value of TZS 3,355.5 million, increased by 76.3 percent compared to June 2021 and decreased by 18.0 percent compared with the previous month. Food and live animals section contributed 65.0 percent (TZS 2,181.5 million) of the total exports in June 2022 (table 2).

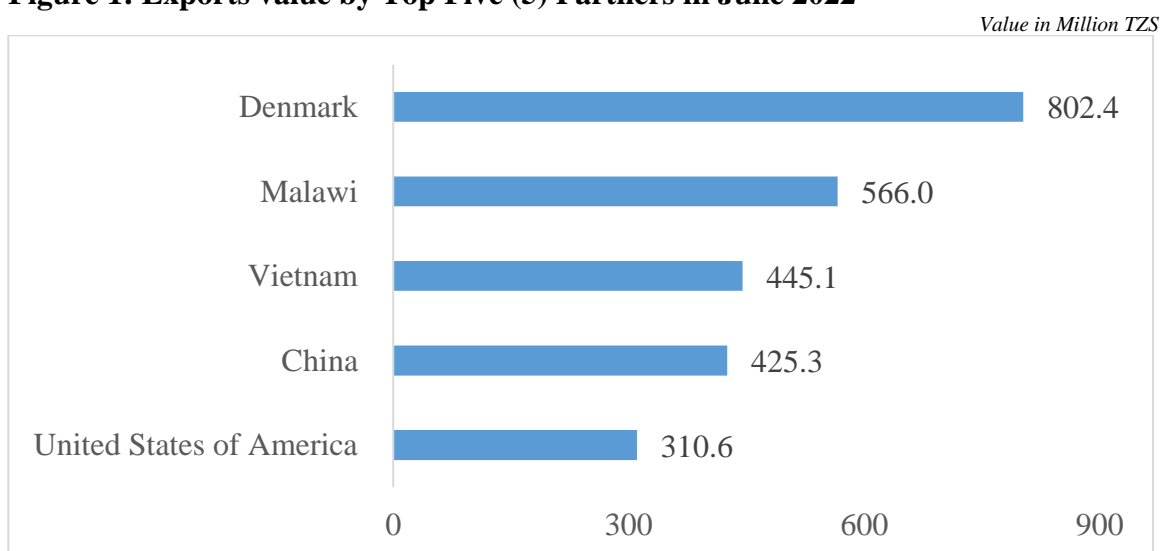

3. Exports by Top Five Partner in June 2022

The top five trading partners for exported goods in the June 2022 accounted 76.0 percent of the total value of exported goods. Major export destination was Denmark that accounted 23.9 percent (TZS 802.4 million) of the total export in June 2022 (Figure 1).

4. Imports Statistics

June 2021 recorded a total import value of TZS 102,372.7 million, which increased by 40.9 percent compared to June 2021 and by 20.3 percent compared to previous month.

Mineral fuels, lubricants and related materials section contributed 41.6 percent (TZS 42,572.7 million) of the total value imported followed by Manufactured goods classified chiefly by material (16.6 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for June 2022 was TZS 18,907.3 million which decreased 23.7 percent compared to the corresponding month of 2021 and increased by 24.7 percent compared to previous month.

Imports value of capital goods was TZS 17,805.0 million which decreased by 13.5 percent compared to the corresponding month and by 14.1 percent compared to the previous month.

Imported value of intermediary goods was TZS 65,660.4 million which increased by more than hundred percent compared to corresponding month and by 33.4 percent compared to previous month (Table 4).

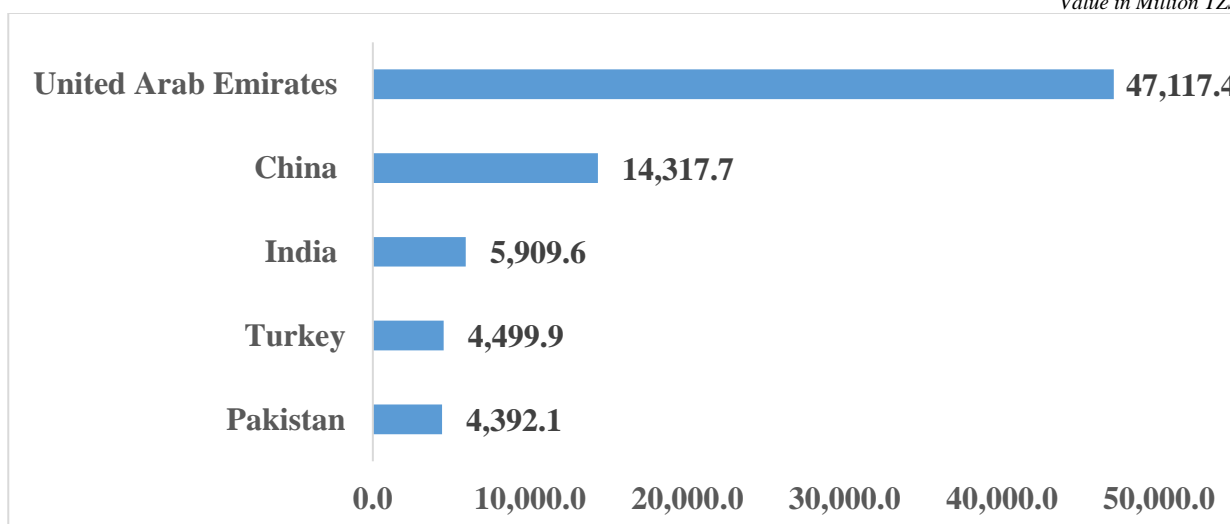

6. Imports by Top Five Partner in June 2022

The top five trading partners for imported goods in the June 2022 contributed 74.5 percent of the total import. Imports were mainly from United Arab Emirates (46.0 percent, TZS 47,117.4 million).
